

The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your November 22, 2019 letter reporting a serious deviation from the provisions of the *Guide for the Care and Use of Laboratory Animals* at the University of Chicago, following up on an initial report on October 15, 2019. According to the information provided, OLAW understands that a mouse had been subjected to a survival surgery not described in the approved protocol and was housed in a laboratory not approved as a satellite facility.

The immediate action taken upon discovery consisted of euthanizing the mouse. Because the incident constituted a repeat finding of noncompliance, the Institutional Animal Care and Use Committee (IACUC) requested a corrective action plan from the investigator addressing laboratory oversight and compliance. In response the investigator euthanized all animals, terminated all protocols, and stopped doing animal research.

Based on its assessment of this explanation, OLAW understands that measures have been implemented to correct and prevent recurrence of this problem. OLAW concurs with the actions taken by the IACUC to comply with the PHS Policy on Humane Care and Use of Laboratory Animals. Please ensure that the NIH grant was not charged for any unauthorized animal activities. Thank you for keeping OLAW apprised on this matter.

I write to provide the final report of an incident the University of Chicago IACUC determined represented a serious deviation from the provisions of the *Guide for the Care and Use of Laboratory Animals*. A preliminary report was provided by email on October 14th by

During the September semi-annual facility inspection, the inspection team discovered a mouse being housed in an investigator laboratory that had undergone survival surgery to mark the lymphatic system. Neither the survival surgery nor the housing within the laboratory was described in the approved animal care and use protocol. The animal was euthanized at the time of the inspection.

This was the second time the laboratory was discovered to be performing procedures not approved by the IACUC and the Committee was greatly concerned that appropriate laboratory oversight was not being provided. Therefore, the Committee requested the investigator submit a comprehensive plan for laboratory oversight that demonstrated a concern for animal welfare and would ensure compliance with approved protocols, policies and guidelines. Until an acceptable plan could be devised, the investigative group would be subjected to random laboratory inspections, restricted from removing animals from the central facilities and restricted from purchasing additional animals. The Animal Resources Center would also provide additional oversight of the animals on census and housed in the central facility to monitor their welfare. The protocol under which the animal was assigned was supported by NIH Grant R01HL128228-01A1.

In response to the concerns presented by the Committee and due to other factors, the investigator decided to terminate all animal research in the laboratory and requested expiration of all their approved animal care and use protocols. All animals associated with the protocols have been euthanized and the protocols expired. We trust that the measures taken by the Committee and the investigator to resolve this non-compliance incident are appropriate.
