The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your January 22, 2020 letter reporting an instance of noncompliance with the PHS Policy on Humane Care and Use of Laboratory Animals at the Thomas Jefferson University following up on an initial November 5, 2019 notification by telephone.

According to the information provided, this Office understands that the Thomas Jefferson University Animal Care and Use Committee (ACUC) determined that instances of noncompliance occurred with respect to: a cage of 5 mice found dead by animal care staff on September 10, 2019. It was determined that the O-ring holding the sipper tube in place on the bottle-top failed, allowing the sipper tube to be pushed upwards into the bottle preventing access to water. It is noted that the project was privately funded. The final report states that animal care staff was previously unaware of this defect. Corrective actions included:

- 1) Animal care staff being trained to identify this malfunction.
- 2) Water bottle inventory was inspected, and new bottle tops were purchased to replace faulty tops.

Based on its assessment of this explanation, OLAW understands that the Thomas Jefferson University has implemented appropriate measures to correct and prevent recurrences of these problems and is now compliant with provisions of the PHS Policy. We appreciate being informed of these matters and find no cause for further action by this Office.

Thomas Jefferson University, in accordance with Animal Welfare Assurance #D16-00051 (A3085-01) and PHS Policy IV.F.3., provides this incident report regarding Animal Use Protocol #02142. This incident was first reported to OLAW via a phone call made on November 5, 2019 by

The animals involved in this incident were mice. On September 10, 2019, during regular room maintenance, animal care staff found one cage containing five deceased animals. During the IACUC investigation, it was determined that the O-ring holding the sipper tube in place on the bottle-top failed, allowing the sipper tube to be pushed upwards into the bottle preventing access to water. This defect was previously unknown to the animal care staff. The following corrective measures were implemented to prevent future occurrences:

- 1) Animal care staff were trained to identify this malfunction.
- 2) Water bottle inventory was inspected and new bottle tops were purchased to replace faulty tops.

This project is privately funded. As a result, this incident was not reported to the funding source.
