Dear Dr. Taraschi,

The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your January 2, 2020 letter reporting an instance of noncompliance with the PHS Policy on Humane Care and Use of Laboratory Animals at the Thomas Jefferson University following up on an initial July 29, 2019 notification by telephone.

According to the information provided, this Office understands that the Thomas Jefferson University Animal Care and Use Committee (ACUC) determined that instances of noncompliance occurred with respect to: 20 mice that disappeared from an investigator's animal colony in the central facility. The principal investigator informed the IACUC office and veterinary staff and an investigation was initiated. Laboratory Animal Services (LAS) and PI staff members were interviewed, video surveillance recordings and card swipe records were reviewed, and no conclusive explanation could be reached. The corrective action that resulted from the incident was the installation of a new surveillance camera in the animal housing room. The letter states the new camera system allows for greater oversight in this location and will assist in more effectively managing any future incidents. It is noted that the final report did not include the funding source involving this incident.

Based on its assessment of this explanation, OLAW understands that the Thomas Jefferson University has implemented appropriate measures to prevent recurrences of these problems and is now compliant with provisions of the PHS Policy. We appreciate being informed of these matters and find no cause for further action by this Office.

Thomas Jefferson University, in accordance with Animal Welfare Assurance #D16-00051 (A3085-01) and PHS Policy IV.F.3., provides this incident report regarding Animal Use Protocol #01927. This incident was first reported to OLAW via a phone call made on July 29, 2019 by

The animals involved in this incident were mice. On June 5, 2019, a Principal Investigator e-mailed IACUC Office and veterinary staff to inform them that twenty naïve wild-type C57BL/6 mice had disappeared from his animal colony in the central animal facility. More specifically, the twenty animals comprised of four cages with five animals each. An in-depth investigation into this matter was promptly initiated. Both Laboratory Animal Services (LAS) and PI staff members were interviewed on multiple occasions to try to gather any pertinent information. Video surveillance recordings and card swipe records for access into the vivarium and animal housing room were also reviewed but could not provide a definitive answer as to what had occurred to cause the animals to disappear.

After thoroughly exploring this matter and exhausting all investigative avenues, no conclusive explanation could be reached, but one direct and preventative action resulting from this incident has been the installation of a new surveillance camera in the animal housing room where the incident occurred. This new camera allows for greater oversight in this location and will assist in more effectively managing any future incidents.
