Dear Dr. Byerly,

The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your June 7, 2018 letter reporting an instance of noncompliance with the PHS Policy on Humane Care and Use of Laboratory Animals at Uconn Health, following up on an initial report on May 17, 2018. According to the information provided, OLAW understands that expired analgesic drugs had been given to eight mice following surgery. The mice did not show signs of pain or distress due to receiving the expired drugs.

The corrective actions consisted of counseling the investigator to discard the expired drug, obtain a new bottle, and not to use any expired anesthetics or analgesics on animals.

Based on its assessment of this explanation, OLAW understands that measures have been implemented to correct and prevent recurrence of this problem. OLAW concurs with the actions taken by the institution to comply with the PHS Policy.

Dear Dr. Morse-

I am writing to you to provide a final report of an incident of non-compliance at Uconn Health. You were originally notified of this incident by email from our IACUC Administrator on May 17, 2018.

The original notification informed you that a PI had given mice expired Buprenorphine for post-surgical analgesia. This was found during our semi-annual inspections of the laboratory. The PI was informed that they could not use expired drugs in laboratory animals and was directed to dispose of the Buprenorphine and obtain a new, unexpired vial.

The IACUC reviewed the records associated with this incident and it was determined that 2 cages of mice, 4 mice per cage, had received the expired Buprenorphine. Review of post-surgical monitoring records did not indicate that mice were in any unrelieved pain/distress due to receiving the expired analgesic.

This incident was brought to the attention of the IACUC during the May 31, 2018 IACUC meeting. The IACUC was satisfied that the incident was resolved. The IACUC sent a letter to the PI to remind them that the use of expired drugs for anesthetic or analgesics purposes is prohibited under federal regulations.

This non-compliant activity was not funded by federal PHS funds.
