Dear Dr. Byerly,

The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your December 20, 2019 letter reporting an instance of noncompliance with the PHS Policy on Humane Care and Use of Laboratory Animals at UConn Health, following up on an initial report on December 4, 2019. According to the information provided, OLAW understands that an approved bone defect surgery was conducted on a rabbit but the radius was inadvertently impacted rather than the ulna as stated in the protocol.

The corrective actions consisted of the Attending Veterinarian counseling the research staff and having the Principal Investigator amend the protocol to allow use of either bone. The rabbit was able to be used for the study and recovered without any signs of pain or distress.

Based on its assessment of this explanation, OLAW understands that measures have been implemented to correct and prevent recurrence of this problem. OLAW concurs with the actions taken by the institution to comply with the PHS Policy.

Dear Dr. Morse-

I am writing to you to provide a final report of an incident of non-compliance at UConn Health. Our IACUC Administrator provided an initial report via email on December 4, 2019.

On November 21, 2019, a rabbit surgery was performed under an approved IACUC protocol. The surgeon operated on a rabbit limb to create a segmental defect on the rabbit ulna approaching medially. In the middle of the surgery, the Attending Veterinarian was called in to clarify the positioning/approach of the defect. It was clear based on radiological evidence that the defect was created in the radius instead of the ulna.

The Attending Veterinarian discussed the issue with the research staff; it was felt that the research was still viable as other regeneration studies in rabbits have tested and used both the radius and ulna due to their similar size and anatomy. He suggested that the researchers modify the protocol to include both bones as an option.

The Committee representative spoke with the surgeon who performed this surgery to determine what might have happened to allow the incorrect bone being used in the segmental defect surgery. The surgeon stated that typically the animal is positioned in a way that allows for a medial access to the ulna; however, the animal had been draped and she did not realize that the rabbit was in a different position that led to the wrong bone being used.

The IACUC discussed this incident during its December IACUC meeting. The IACUC determined that this was an unfortunate error that did not result in the euthanasia of the animal as the defect could still be used in research. The modified protocol has been submitted to the IACUC but it is not approved. The Committee determined that the rabbit did not show any signs of pain or distress related to the error that required any veterinary intervention; in this case, the Committee determined that no further action was required by the researchers.

Subject: Initial report of protocol non-compliance

Good morning-

I'm writing on behalf of our Institutional Official to inform you of a non-compliance event that occurred at UConn Health, A3471-01/D16-00295.

On 11/21/19, a rabbit surgery was performed under an approved IACUC protocol. The surgeon operated on a rabbit limb to create segmental defect on ulna approaching medially. In the middle of the surgery, the attending veterinarian was called in to clarify the positioning/approach about the defect. It was clear based on the radiograph that the defect was created in the radius instead of ulna.

The attending veterinarian recommended to them to modify the protocol as rabbit ulnar/radial non-union bone regeneration with composite microspheres scaffold rather than just an ulnar-non-union model. Regeneration studies in rabbits have tested/used both radius and ulna, due to their similar size/anatomy. The researchers have since submitted an modification of the approved protocol to do this but it has not, as yet, been approved.

We will be discussing this during our December IACUC meeting (12/19/19) and I will send you a final report of this non-compliance after that date.
