III. ADVERSE EVENT

Ref# ______, "Breeding Eastern Mosquitofish (Gambusia holbrooki)," .

- Email communication in May detailed that there was water quality issues in the ponds on the 5th floor and the PI stated that he would "work on it". In June, a follow-up email from the PI explained that "electrical storms" impeded work on the ponds. In September, the PI disclosed that they were have issues with their deionized water system.

- The committee made recommendations for the Corrective Action Plan. They request that the PI create or modify an SOP to detail what the water changes entail. Checklists should be added to the SOP, to ensure procedures are followed and the necessary checks are made. In addition, the PI is asked to explain what the water source is in the event that the deionized water supply system is not working.

- AAALAC Site Visit The findings from the visit were shared with the committee members. The committee discussed the SFI that pertained to the quail being donated to land owners that permit hunting, which conflicted with the current SOP that states that donated animals will be used as pets. The committee suggested either finding alternative land owners that would adopt the animals and not allow hunting on their lands, or updating the SOP to allow donating animals to any land owner (including those that allow hunting on their grounds). Regarding the SFI that pertained to sanitation of the quail holding cages/boxes, the committee discussed either purchasing disposable cages or obtaining additional cages that will be rotated as they are sanitized at the ACF cage washers. The committees discussed the remaining findings that will be addressed, as suggested by the site visitors.
- Single-housing SOP The committee reviewed the SOP created to explain the need and procedure for single-housing of animals. Committee members made small edits to include "for purposes of the health of the animal" and for "long-term health reasons" in the social housing exceptions portion of the document. A committee

	member explained that behavioral interaction experiments may be considered an environmental enrichment. The committee approved the SOP.

1. Reference : "Mechanisms of Neurodegeneration in ALS and PD," submitted by

A committee member summarized the specifics of the research that is being proposed in the protocol:

Approximately 200 rats will develop ALS. Some transgenic lines have already been created at previous institution and new transgenic lines will be created. Currently the PI has about 15 transgenic lines.

The committee suggested that more explanation of what would be done to the rats be explicitly listed in the protocol. In addition, the committee is suggesting that the monitoring of the animals be described. Furthermore, the funding proposal needs to be attached to the application. It seems that the grant is NIH funded. If that is the case, the NIH should be made aware of the move to our institution.

The protocol seems incomplete and requires additional information, specifically in the experimental design since it is currently unclear. Therefore, the committee suggests that a breeding protocol be submitted, in order to allow for the transfer of animals from the previous Institution. The PI will need to submit an IBC exemption solely to maintain the existing colonies, not crossbreed them. Under this breeding protocol, no cross-breeding can occur.

The AV has verified that animals that are being transferred from the PI's prior institution have a clean health report; however he will have them tested once they arrive at our Facility.

The committee agreed that this protocol should be tabled and the PI would need to submit three separate protocols. One would be for breeding existing lines, another for creating transgenic rats and a 3rd for experimental procedures. In addition an SOP to check for multi-dysfunctions must be provided. The suggestion to create a breeding protocol in the time being will be made to the PI.

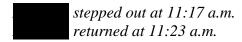

The meeting began with one of the members mentioning their concerns over qualitycontrol of the procedures. Due to the complexity of the procedures, the non-human primate animal model, is questioned. They suggested that a smaller, less sentient, model seems to be a more appropriate model to consider, and if successful, then the progression to the non-human primate model may be acceptable. Another member stated that the cost-benefit has not been justified properly in the protocol application. Based on the information provided in the literature searches and project description, there is no evidence that has shown successful outcomes of the proposed procedures in any animal model. The PI proposes to conduct work with the Mannheimer Foundation. Because PHS funds are being used for this proposed research, the facility will be required to have an OLAW Assurance. It has not been provided at this time. The pain categorization of the procedures needs to be clarified. There is a statement in the Description of Euthanasia Methods section that states "all animals that die or are humanely euthanized must be necropsied within 24 hours of death – whenever possible". This statement will need to be clarified. The committee also asks that anticipated mortality rate be provided in this clarification. "Death as an endpoint" would be appropriate if animals will perish as a result of the proposed procedures. The committee suggests that a pilot study be performed, along with in-vitro studies. A member suggested that the cost-basis is not justified and questions if there is enough experience in performing these procedures, to carry them out correctly. A committee member also brought up the marketability of this research. The protocol does not make mention to this, and the committee would like to know if there is projected/anticipated marketability that result from the data collection. If so, should there be a conflict of interest, it would need to be disclosed. Regarding the Duplicative Literature section, the PI is asked to provide a better summary of the literature searched, as only reference information is currently provided. Lastly, the committee would like to know the role of in this protocol, if any. She is listed as a key personnel in the funding proposal.

III. NEW PROTOCOLS

The committee members discussed that the PI did not fully address the comments and concerns from the previous review of this protocol. There are concerns over potential

use of created compounds/cocktails that the PI proposes. There is a lack of preliminary data regarding the proposed media being used. The committee suggests that these compounds be experimented on isolated tissues, before used in-vivo and must show that positive outcomes are obtained. The committee again suggests the use of a less sentient model, such as a rodent model, with gradual progression, as positive results and proof of concept are achieved. There are concerns regarding the pain categorization, as experiments propose the opening of the chest cavity, and there is not clear indication of pain alleviation with medication. The PI would need to provide more precise detail explaining the procedures. The committee proposes that the PI should submit a new protocol with a less sentient model, as a pilot study for this protocol.
