This report summarizes the semiannual report of the Animal Care and Use Committee (ACUC), as required by the Public Health Service (PHS) Policy on Humane Care and Use of Laboratory Animals (Policy), Section IV.B.1.-3., the 8<sup>th</sup> Edition of the Guide for the Care and Use of Laboratory Animals (Guide), and the Animal Welfare Act (AWA) regulations, as applicable and as a condition of this Institution's Animal Welfare Assurance on file with the Office of Laboratory Animal Welfare (OLAW).

#### Overview

The ACUC conducted its semiannual evaluation of the AGMUS' Animal Care and Use Program satellite facility inspection, located at the Universidad del Turabo, the affiliated campus of the Ana G. Méndez University System that has authorization for the housing and use of laboratory animals relating to research since October 4, 2007. The following members were present in this inspection: Dr. Wanda L. Orta, Dr. Mariel Pérez,

(b) (6) The inspection was held on August 25, 2017.

At present, the UNE-AGMUS has the housing and care of the animals, of concern, authorized by the corresponding governmental agencies and is under the supervision of the AGMUS ACUC.

Online certification is available and required to all investigators that will be planning to use animals in their research; they can access the training through the CITI program IACUC training

Retrieved from Animal Research Laboratory Overview (ARLO)

and Responsible Conduct of Research (RCR). This site is in full compliance with all requirements of applicable federal law. The AGMUS achieved its official Assurance agreement approval on November 14, 2005 and a renewal approval on August 2013.

#### Evaluation of the Animal Care and Use Program

The AGMUS-ACUC is currently conducting a comprehensive evaluation of the Institution's Animal Care and Use Program at the Universidad del Este (UNE), the only affiliated campus of the Ana G. Méndez University System with the authorization for the housing and use of laboratory animals relating to research, since October 7, 2005, actually program is being revised to integrate the new guidelines. This evaluation is being taking into consideration all applicable laws and regulations, including the 8<sup>th</sup> edition of the *Guide*.

#### Inspection of Animal Facilities

The AGMUS-ACUC inspected the animal facilities at UNE on December 16, 2016 and the animal satellite facility at Turabo on August 25, 2017 using the 8<sup>th</sup> edition of the *Guide*, and, as applicable, 9 CFR Chapter I, 2.31.

The facilities include three (3) rooms. Room A is used for gowning and behavioral research experiments. (b) (4) has an animal quarantine room using bio-bubble technology, an area for surgery, and an area for preparation. quarantine bio-bubble is not in use. (b) (4) includes a cage area using bio-bubble technology.

No animal research is being conducted at this facility. Currently Animal facilities are closed. A proposal was submitted in April 4, 2014 to a PR- INBRE for funding to remodel the facility and comply with the new guide for the care and use of laboratory animals 8<sup>th</sup> edition and other regulations.

The animal satellite facility is currently in use by the Principal Investigator, Jimmy de León, which has an active research on *Danio rerio* species on room (b) (4) at Turabo. The research conducted involves several fish tanks and all the required equipment necessary for the research.

Attached of this report is Appendix 1 Semiannual Facility Review Report of the UNE's site that includes the corrections that needs to be adjusted previous of the nest inspection and Appendix 2 Semiannual Satellite Facility Review Report of the Turabo's site.

#### Institutional Policies and Responsibilities (Others)

The following ACUC Membership and Functions as presented in the semiannual program review checklist of OLAW as pertains to the Ana G. Méndez University System are adequate: membership, committee composition, assigned responsibilities and authority to the Committee and preparation of reports to the Institutional Official. The semiannual review of the Animal Facilities was conducted and the evaluation of the Animal Care and Use Program will be conducted in the next convened meeting of the ACUC.

The AGMUS-ACUC Policies and Procedures, Animal Care and Use Handbook were approved by the Committee and by the AGMUS' President, Dr. José F. Méndez with Executive Order: 07-2009. These ACUC Policies and Procedures were reviewed and approved by the ACUC and by the AGMUS' President with Executive Order: 05-2012 in order to adopt the new edition of the Guide, as required by OLAW. The revised Policy is available on the AGMUS-ACUC website (compliance.suagm.edu).

In the areas of ACUC Records and Reporting requirements, ACUC certifies that it is carrying out all of the required aspects of this section for review and will integrate into its procedures, compliance with each of the recommendations in the semiannual review checklist.

In Veterinary Care, Dr. Wanda Orta has been contracted since of October 24, 2005 who has the required credentials and experience. Dr. Orta also serves as the ACUC Co-Chair. The Veterinarian in coordination with the corresponding Principal Investigator and UNE officials developed the Animal Care and Use Program and all related procedures. As stated above, the program is being reviewed by the ACUC Committee.

In Personnel Qualifications and Training, ACUC transmitted a formal training program in May 16, 2008 and disseminated the information on a regular basis. At present, all on-site trainings have been carried out under the auspices of the IACUC of UPR-RCM. An online training program at AGMUS has been approved and in place. Also on July 24, 2009 the IO informed that the AGMUS-ACUC Certification is available through CITI Program and the instructions available at the ACUC website.

The Office of AGMUS' Occupational Safety and Health has the following policies and procedures in place and presented in manual formats: Management and Disposition of Regulated Biomedical Waste, Security Warnings and Signs, Plan for Storage of Reactive, Security in the Management of Substances and a Chemical Health, Safety and Hygiene Plan. The Office of AGMUS' Occupational Safety and Health and UNE has generated policies and procedures that incorporate specific attention to the care and use of animals and the operation of an animal care facility. This Office and ACUC will also develop a formal training program to disseminate the information on a regular basis.

At present, all specialized training relating animal care and use are carried out under the auspices of the IACUC of UPR-RCM should be continued as is, until a formal specialized training program at AGMUS is approved and in place.

The AGMUS has a funded PHS grant, but at this moment, there is no research with animals being conducted at this facility. Inspection will be performed per the PHS policies. The *schedule* and status of the semiannual evaluation for the Animal Care Facilities in UNE will be performed as follows:
