#### **Program Changes**

In 2019, the Division of Agriculture constituted a separate IACUC for the oversight of protocols involving agricultural animals; the University of Arkansas IACUC will continue to review biomedical and field studies involving non-agricultural vertebrate animals. The Division of Agriculture IACUC will also be responsible for Division of Agriculture semiannual program reviews and facility inspections.

The University of Arkansas has requested that its registration with USDA/APHIS be canceled as no research or teaching activities involving USDA-covered species are being conducted at the university. In the event that university researchers wish to conduct studies involving USDA-covered species, registration with USDA will be reactivated.
