Dear Dr. Cornett,

The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your April 27, 2017 letter reporting an instance of noncompliance with the PHS Policy on Humane Care and Use of Laboratory Animals at the University of Arkansas for Medical Sciences, following up on an initial report on April 7, 2017. According to the information provided, OLAW understands that a mouse was subjected to anesthesia, insertion of probes to measure heart and respiratory rate, and restraint in a plastic cone although none of these activities had been approved by the Institutional Animal Care and Use Committee (IACUC). The mouse survived the procedures without incident. Also one cage of mice had been housed in the laboratory over the weekend although the area had not been approved as a satellite facility.

The corrective actions consisted of informing the Principal Investigator (PI) about the issues, directing the PI to review the current protocols to ensure that all proposed activities were included and to submit amendments for any additional procedures, and informing the PI that new procedures could be tested under an IACUC approved training protocol and that alternate housing rooms were available. The institutional post-approval monitoring program will focus on laboratory training sessions for the next several months.

Based on the information provided, OLAW is satisfied that appropriate actions have been taken to investigate, correct, and prevent recurrence of the noncompliance. We appreciate having been informed about this matter and find no cause for further action by this Office.

The University of Arkansas for Medical Sciences (UAMS), in accordance with Assurance A3063-01 and PHS Policy IV.F.3., provides this final report of noncompliance related to an unapproved procedure performed on one mouse.

On April 4, 2017, the Attending Veterinarian and Clinical Veterinarian met with an Investigator regarding restraint alternatives for a protocol addendum he had submitted to the Institutional Animal Care and Use Committee (IACUC). During that meeting, the Investigator showed the Veterinarians data demonstrating that he had performed the proposed procedure on one mouse on March 22 without IACUC approval. Specifically, the mouse was placed in a plastic cone with subcutaneous probes inserted to measure heart and respiratory rates. The mouse was also dosed with Ketamine at two different time points during the restraint. The heart and respiration rates measured did not appear to indicate that the animal was in distress. According to the data, the animal did survive with no welfare issues. However, none of these procedures (restraint, probes, Ketamine dosing) were approved by the IACUC.

During the initial investigation to determine how the noncompliance occurred, the Attending Veterinarian received an anonymous complaint on April 10, 2017, that the Investigator had a cage of mice housed in his laboratory over the weekend. The Attending Veterinarian and the Clinical Veterinarian visited the laboratory and confirmed with the Investigator that in fact one cage of mice had been left there all weekend, even though the laboratory is not approved as a satellite facility. The Veterinarians observed the animals and did not note any concerns or welfare issues. The experiments were completed and the animals euthanized in accordance with the IACUC approved protocol that day.

This work was conducted under a center grant from the National Institute of General Medical Sciences, 5P30GM110702-03. The Principal Investigator of that grant has been informed of the situations.

In order to correct these noncompliance issues and ensure that they do not recur, the following actions were taken:

- 1. A meeting was held on April 12, 2017, between the Investigator, the IACUC Chairman, the Attending Veterinarian, the Clinical Veterinarian, the Research Compliance Officer, and the Research Compliance IACUC Analyst. During this meeting, discussions focused on how the noncompliance occurred, what the correct process would have been, and how to proceed in the future.
- 2. The Investigator has been instructed to review all current Animal Use Protocols to be certain all necessary procedures and drugs are included prior to beginning the work, even for a pilot project to determine if the procedure would work, and to submit an addendum to add procedures or drugs as necessary.
- 3. The Investigator was informed that he could also contact the Division of Laboratory Animal Medicine to inquire about using their IACUC-approved training protocol to test new procedures before submitting a new protocol to the IACUC.
- 4. The Investigator was also informed that he could contact the Division of Laboratory Animal Medicine to find an alternate housing room should he ever need to return animals at the end of the day.
- 5. These events were discussed at the convened IACUC meeting held on April 21, 2017.

The initial incident involving unapproved procedures was first reported to you on April 7, 2017, via a telephone call from me as the UAMS Institutional Official. As the unapproved housing was discovered during the course of our investigation into that matter, we are including it in this final report. We did not make a separate initial report of the unapproved housing incident.

In order to further educate our animal research community and hopefully reduce instances of noncompliance institution-wide, the IACUC has determined that our Post Approval Monitoring program should be enhanced for the next several months to focus more on training sessions tailored for individual labs and less on reviews of individual protocols. This process will begin immediately.

UAMS is committed to protecting the welfare of animals used in research and appreciates the guidance and assistance provided by OLAW in this regard. Should you have any questions regarding this report, please feel free to contact me.
