Dear Dr. Lakin,

The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your January 14, 2020 letter reporting an instance of noncompliance with the PHS Policy on Humane Care and Use of Laboratory Animals at the University of Colorado- Denver. According to the information provided, OLAW understands that mice were subjected to tail clipping after 21 days of age, which violates Institutional Animal Care and Use Committee (IACUC) policy. The individual responsible was also involved in other types of noncompliance including overcrowding cages and incorrectly identifying the sex of mice.

The corrective actions consisted of IACUC co-chairs meeting with the Principal Investigator and the individual, removing the individual from managing the majority of the breeding colony, and retraining the individual on sexing mice and preventing overcrowding.

Based on its assessment of this explanation, OLAW understands that measures have been implemented to correct and prevent recurrence of this problem. OLAW concurs with the actions taken by the IACUC to comply with the PHS Policy.

Dear Dr. Morse;

The Institutional Animal Care and Use Committee (IACUC) at the University of Colorado Denver | Anschutz Medical Campus received a report of an animal welfare incident; specifically mice were tail clipped after the standard 21-day timeframe set by CU Denver IACUC policy. This is not the only infraction by this associate. At other times, overcrowded cages have been reported, and animals have been incorrectly sexed.

At a convened meeting of a quorum of the IACUC, a majority of the quorum present determined that a meeting with the PI, the associate and the IACUC Co-Chairs be held. This has been done. Management of the majority of the breeding colony has been taken away from the associate. Additionally, training on how to properly manage a breeding colony has been done, including properly sexing mice and how to prevent overcrowding.

The IACUC determined to accept the actions as taken and further determined that the Office of Laboratory Animal Welfare (OLAW) be informed of this incident. (NIH Grant #5PO1HL014985)
