This response is in reply to your Freedom of Information Act (FOIA) request dated April 8, 2019 and received by the U.S. Department of Agriculture (USDA), Animal and Plant Health Inspection Service (APHIS) on the same date. Your request was assigned FOIA tracking number 2019-APHIS-03247-F. Your FOIA request seeks:

All of the following materials regarding experiments on dogs at White Oak Animal Program (Registration#: 51-F-0025) created between January 1, 2017 and April 8, 2019: All official warnings; settlements; minutes; consent decrees; Column E ("animals used in research; pain involved; no pain drugs administered") exemption justifications; inspection reports, and case files related to those reports, including photos, audio, and/or video footage; applications for registration and renewals; any correspondence appealing a report or advising about a personnel change; records of change of operations, protocol suspension, and uncorrected significant deficiencies from a semiannual inspection; and/or any other electronic surveillance communications.

Upon receipt, your request was forwarded to the Animal Care (AC) and Investigative and Enforcement Services (IES) Program offices to conduct a search of their files for records responsive to your request. IES began a search of their electronic files on April 16, 2019 but did not locate any responsive records. AC began a search of their electronic files on May 15, 2019 but did not locate any responsive records.
