The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your January 22, 2018 letter reporting an instance of noncompliance with the PHS Policy on Humane Care and Use of Laboratory Animals at Rutgers University. Your letter supplements the information in the initial phone report on October 19, 2017. According to the information provided, OLAW understands that on July 24, 2017 it was determined that a lab had been performing transcardial perfusion in mice although this procedure was not specified in the approved protocol. This activity was not funded by the PHS.

Corrective actions included counseling of the PI by the Executive Director of Comparative Medicine Resources (CMR) who also confirmed that the procedure itself was performed correctly. An amendment to add the procedure to the protocol was submitted and approved.

The prompt consideration of this matter by Rutgers University was consistent with the philosophy of institutional self-regulation. Similarly, the actions taken to resolve the issue and prevent recurrence were appropriate. Although this activity was not PHS funded, the application of the standards of the PHS Policy across the animal care and use program reduces any potential appearance of a double standard. We appreciate being informed of this matter and find no cause for further action by this office.

Rutgers University wishes to make a final report regarding an incident in which a non-survival procedure was performed off protocol. lecondary Individual IACUC Manager, first reported the incident via telephone call on October 19, 2017.

On July 24, 2017, it was discovered that a lab had been performing transcardial perfusion in mice without it being specified in the protocol.

The following actions were taken in response to this incident:

- The PI was counseled by the Executive Director of Comparative Medicine Resources (CMR).
- The Executive Director of CMR confirmed the procedure was being performed properly and the issue was limited to it not being included in the protocol.
- An amendment to add transcardial perfusion into the protocol was submitted and approved.
- At its regular meeting on September 19, 2017, the IACUC reviewed and discussed this incident
 and unanimously voted to report this matter to OLAW. The IACUC also voted to accept the
 actions noted above as corrective actions and recommended no further action regarding this
 incident.

Please note that while this study was not supported by NIH funds, in accordance with our Assurance, we report all serious concerns to OLAW.
