Dear Dr. Vrana,

The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your June 13, 2019 letter reporting an instance of noncompliance with the PHS Policy on Humane Care and Use of Laboratory Animals at Pennsylvania State University- Hershey Medical Center. According to the information provided, OLAW understands that analgesia had not been given following surgery. Several analgesics were described in the protocol but none were being used.

The corrective actions consisted of the Institutional Animal Care and use Committee (IACUC) directing the investigator and staff to follow the protocol and give the analgesics as described. Surgical logs documenting peri-operative care and provision of analgesia will be maintained and will be monitored by the IACUC to confirm compliance.

Based on its assessment of this explanation, OLAW understands that measures have been implemented to correct and prevent recurrence of this problem. OLAW concurs with the actions taken by the IACUC to comply with the PHS Policy. Please remember to indicate the species involved.



Re: Failure to adhere to IACUC-approved protocols; Animal Welfare Assurance D16-00024 (A3045-01); P01HL134609

Dear Dr. Morse,

The Pennsylvania State University College of Medicine, in accordance with Assurance D16-00024 (A3045-01) and PHS Policy IV.F.3., provides this report of a noncompliance regarding an incident in which post-surgical analgesics were not provided after a surgical procedure as described on the protocol. During semi-annual inspections (October 2018), a lab member stated to the inspection team that they do not give analgesia after surgery. The protocol describes Carprofen and/or Buprenorphine to be administered at the start of surgical procedures. There is an additional statement that "Buprenorphine SR as analgesic will be given once after the surgery."

To address the situation, the IACUC interviewed the investigator and team and recommended the following corrective action plan:

- 1. That the protocol will be followed hereon, and analgesics will be given pre- and postsurgery as described.
- 2. That logs of each animal under surgery, including peri- and post-operative care and analgesia be kept for review by the IACUC for compliance.

Implementation of corrective actions were confirmed during spring semi-annual inspections in April 2019, when surgical logs were reviewed by the IACUC inspection team and the laboratory's surgical preparation and process were reviewed.

The findings of the investigation were reviewed at a convened meeting of the IACUC on November 26, 2018. The IACUC recommended to the IO that the incident be reported to OLAW.
