The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your December 4, 2019 letter reporting an instance of noncompliance with the PHS Policy on Humane Care and Use of Laboratory Animals at the Seattle Children's Research Institute following up on an initial May 13, 2019 notification by email.

According to the information provided, this Office understands that Seattle Children's Research Institute Animal Care and Use Committee (ACUC) suspended three approved protocols in connection with a Division of Investigative Oversight (DIO) investigation. These protocols investigate the role of T-cells, inflammatory cytokines and enteric pathogens in the development and prevention of autoimmune diseases, such as experimental autoimmune encephalomyelitis and inflammatory bowel diseases, in mouse models. The final report states that the investigator is no longer at the institute and the protocols have been administratively closed. It has also been confirmed that these protocols were PHS-supported activities and the suspension of the protocols were not related to noncompliance with animal activities. We appreciate being informed of these matters and fine no cause for action by this Office.



On May 3, 2019, the convened IACUC suspended three approved protocols in connection with a Division of Investigative Oversight (DIO) investigation, case #6482. These protocols investigate the role of T-cells, inflammatory cytokines, and enteric pathogens in the development and prevention of autoimmune diseases, such as experimental autoimmune encephalomyelitis and inflammatory bowel diseases, in mouse models.

The institution is cooperating with the ongoing DIO investigation and corrective actions will be taken. A final report will be forwarded to OLAW once the corrective action plan is finalized and a decision is made about the protocols. In the meantime, all affected animals have been transferred to the institutional emergency holding protocol to ensure immediate care and oversight.
