Dear Dr. Hendricks,

The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your September 5, 2019 letter reporting an adverse event involving mice at Seattle Children's Hospital Research Institute, following up on an initial report on June 13, 2019. According to the information provided, OLAW understands that nine mice died in a hypoxia chamber due to low airflow. The cause could not be definitively identified but may have been due to central air compressor failure or tampering with the air line by someone not associated with the laboratory.

The corrective actions consisted of installing a backup air supply using oxygen and nitrogen tanks and installing locks to prevent tampering. Backup air systems will also be set up for other laboratories using central compressed air.

Based on its assessment of this explanation, OLAW understands that measures have been implemented to correct and prevent recurrence of this problem. OLAW concurs with the actions taken by the institution to comply with the PHS Policy on Humane Care and Use of Laboratory Animals.

Dear OLAW,

This letter is to provide you with a full explanation of the circumstances and actions taken following an incident at our institution as required by PHS Policy IV.F.3.a.

The Institutional Animal Care and Use Committee (IACUC) office received information that three cages of mice (nine animals total) were found dead in their hypoxia chamber due to insufficient airflow. Two possible causes have been identified:

- 1. Failure of the building's air compressor resulted in insufficient flow; or
- 2. An individual not involved with the experiments tampered with the air line, as the hypoxia chamber is in a shared room.

After the incident, the involved lab implemented the following corrective actions:

- The lab met with SCRI's facility manager and discussed options for installing a backup/failsafe air supply to prevent a building failure from impacting the animals. This involves placement of switchover manifolds with standing gas canisters for both the air line (to prevent low-oxygen conditions) and the nitrogen line (to prevent disruption of the intended low-oxygen conditions).
- 2. The lab plans to install locks to prevent tampering. These modifications will be installed by SCRI's Building and Engineering team.

In addition, the IACUC office has contacted other labs who have experiments that may involve central compressed air sources to confirm backup air is currently set up and if not, help identify appropriate backup mechanisms and how to arrange for installation. The IACUC office will report back to IACUC with a timeline for resolution and ensure designated personnel implement the plan.
