Dear Dr. Moler,

The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your October 5, 2019 letter reporting an instance of noncompliance with the PHS Policy on Humane Care and Use of Laboratory Animals at Stanford University, following up on an initial telephone report on July 9, 2019. According to the information provided, OLAW understands that ten mice died after having been inadvertently left in a transport vehicle overnight with external temperature outside of the acceptable parameters.

The corrective actions consisted of counseling all animal transport drivers, developing a standard operating procedure and checklist addressing animal transportation, and training staff on these procedures.

Based on its assessment of this explanation, OLAW understands that measures have been implemented to prevent recurrence of this problem. OLAW concurs with the actions taken by the institution to comply with the PHS Policy.

As Stanford University's authorized institutional official under its PHS Assurance (Animal Welfare Assurance #A3213-01), I am writing to notify OLAW of a reportable incident as defined in PHS Policy IV.F.3.

#### Description:

At a convened meeting, the IACUC discussed an allegation of noncompliance involving rodents. During a routine transfer of animals, several mouse cages were left in a closed vehicle and may have been exposed to environmental conditions outside of recommended limits. Ten mice died. The APLAC determined that this incident met the definition of serious noncompliance as it constituted a failure to adhere to the PHS "Policy on Humane Care and Use of Laboratory Animals" and resulted in actual harm to animals.

These animals were purchased under an approved protocol that included NIH funding, however, the animals were experimentally naïve and all costs associated with these animals have been refunded.

A preliminary report of this incident was provided to OLAW on July 9th, 2019, via a telephone call from the Associate Director of the Institutional Animal Care and Use Program, Research Compliance Office. The discussion confirmed that this was a husbandry event and did not involve the research investigator.

#### **IACUC Determination:**

An IACUC subcommittee met to review these concerns and the corrective actions that had been taken. Based on its review, the subcommittee recommended that this incident be classified as serious noncompliance as it constituted a failure to adhere to the PHS "Policy on Humane Care and Use of Laboratory Animals".

At the convened meeting, the IACUC discussed the subcommittee's recommendation. A motion to accept this finding was made, seconded and approved. A determination memo from the IACUC Chair has been sent to the Associate Director (AD) of the Veterinary Service Center (VSC).

## Corrective Actions and Follow up:

The AD reported that the following had been done proactively:

 They met with all approved transport drivers in the employ of the VSC to discuss this issue and briefed them on the importance of following all relevant guidelines.

The IACUC requested that in addition to this corrective action that the VSC:

- Institute a new SOP and checklist regarding animal transportation and that the APLAC review these
  documents prior to implementation.
- Train all relevant personnel on the SOP and checklist, and submit documentation of this training to the APLAC for confirmation. A roster of attendees will be provided to the IACUC.

#### **Concluding Remarks:**

The IACUC has carefully reviewed this incident with all parties involved. Stanford believes that a recurrence of an incident of this nature is unlikely as all VSC members have received appropriate training, and the AD and VSC staff are committed to preventing a future occurrence. 
