Dear Dr. Hetzer,

The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your February 11, 2020 letter reporting a serious deviation from the provisions of the Guide for the Care and Use of Laboratory Animals at Salk Institute. According to the information provided, OLAW understands that eight mice died and one was moribund due to lack of access to water. The laboratory staff had weaned the mice and failed to attach water valves.

The corrective actions consisted of euthanizing the surviving mouse and retraining the technician responsible.

Based on its assessment of this explanation, OLAW understands that measures have been implemented to correct and reduce the likelihood of a recurrence of this problem. OLAW concurs with the actions taken by the institution to comply with the PHS Policy on Humane Care and Use of Laboratory Animals and recommends that all investigators and husbandry staff using this type of watering system be reminded to ensure that valves are present and working. Thank you for informing OLAW about this matter.

Dear Dr. Wolff:

The Salk Institute, in accordance with the reporting requirements as defined by PHS Policy IV.F.3 and Assurance A3539-01, hereby communicates the following incident pertaining to NIH grant DK113065, HL088093, DK120808, and DK120480.

In January 2020, ARD Veterinary Services (VS) reported that 3 mouse cages were found with missing water valves. Consequently, 8 mice were found deceased and 1 was found moribund. The investigator failed to respond to VS notifications in a timely manner therefore, VS humanely euthanized the moribund mouse. After further investigation, it was determined that the lab forgot to include water valves when weaning the mice.

The incident was discussed at a convened IACUC meeting wherein committee voted unanimously to:

- 1. Report the incident to OLAW
- 2. Retrain the investigator's technician

The technician completed retraining on January 31st, 2020.
