- 1. Change from a 3yr renewal application to 3yr review report.
 - a. After review of regulatory requirements and IACUC procedures, the IACUC agreed to move from requiring submission of a 3yr renewal application to requiring a triennial review report with continued de novo review by the IACUC. This will assist with reducing administrative burden while maintaining regulatory compliance and performing the de novo review as required.

- 3. IACUC 18 Animal Reuse Policy
 - a. Policy provides requirements for the reuse of vertebrate research animals. This policy has been developed to ensure compliance with the Animal Welfare Act and Public Health Service Policy, and to ensure humane care and use of vertebrate animals.
- 4. IACUC 19 Self-Injurious Behavior Policy
 - a. Policy has been designed to establish standards and ensure that animals exhibiting self-injurious behavior are properly identified and receive intervention and care, as required and appropriate.

 - a. An IACUC application, modified for non-USDA rodent species, has been drafted to assist rodent users with meeting regulatory requirements while reducing administrative burden.
