Dear Dr. Cassis,

The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your January 18, 2019 letter reporting a serious deviation from the provisions of the *Guide for the Care and Use of Laboratory Animals* at the University of Kentucky, following up on an initial telephone report on January 10, 2019. According to the information provided, OLAW understands that two mice died and one required euthanasia after not receiving food after being weaned by research staff. The problem was not noted by the animal care staff during the daily health check.

The corrective actions consisted of disciplining the caretakers and counseling the researchers on proper weaning procedures. The Principal Investigator was issued a letter describing rodent weaning requirements.

Based on its assessment of this explanation, OLAW understands that measures have been implemented to prevent recurrence of this problem. OLAW concurs with the actions taken by the institution to comply with the PHS Policy on Humane Care and Use of Laboratory Animals.

The University of Kentucky Institutional Animal Care and Use Committee (IACUC), through the Institutional Official, is reporting the following noncompliance and deviation from the *PHS Policy on Humane Care and Use of Laboratory Animals* as required by section IV, F, 3a of the PHS Policy.


This incident was initially reported by telephone on January 10, 2019.

On December 17, 2018, a Division of Laboratory Animal Resources (DLAR) technician found a cage of weanling mice with no food. The mice were weaned by research staff on December 3, 2018 and had not been handled by that group since. Two of 4 mice were dead, and one was euthanized for humane reasons. One mouse survived without ill effects.

The IACUC discussed the specifics of the incident at their meeting on January 16, 2019. The IACUC required the following actions in response to this noncompliance:

1. The DLAR supervisor of the two technicians involved took corrective measures as per DLAR guidelines and University of Kentucky Human Resources.
