#### 1. NYSDOH

NYS DOH inspection in July found minor recommendations -

- Opened bags of frog food must be kept in a sealed container with the mill date posted.
- Single housed mice must be provided with environmental enrichment, unless otherwise warranted through an approved IACUC protocol for such restrictions of enrichment.
- Food must be used within 6-months of the mill date, unless the IACUC approves a longer shelf life. At present, the IACUC has a 6-month shelf life approval system for animal food.

And one violation -

- Euthanasia SOP for mice was not updated by the NYS DOH inspection date. This issue was corrected and submitted within the 10-day period as required by NYS DOH.

NYS DOH 2018 Renewal Application for Approval for Use of Living Animals was submitted 11-01-17.

Draw raised the need for red light alarms for people working inside labs because the fire alarms are difficult to hear from inside the lab because of the noise from hoods and more insulated space. Draw promised to follow up on this issue.


