The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your October 3, 2019 letter reporting an instance of noncompliance with the PHS Policy on Humane Care and Use of Laboratory Animals at the University of California San Diego, following up on an initial telephone report on September 5, 2019. According to the information provided, OLAW understands that 40 mice died after their cages flooded due to one cage being placed backwards on the rack and activating the lixit.

The corrective actions consisted of retraining the laboratory staff on proper placement of cages on the rack. The topic of appropriate cage placement is addressed in two institutional orientation training programs.

Based on its assessment of this explanation, OLAW understands that measures have been implemented to prevent recurrence of this problem. OLAW concurs with the actions taken by the institution to comply with the PHS Policy.

Dear Dr. Wolff,

Per PHS Policy IV.F.3, I am writing to advise you of an incident that occurred in a UC San Diego vivarium. On July 15, 2019, a Principal Investigator's laboratory staff accidentally placed a mouse cage backward on the housing rack which activated the lixit to the automatic watering system. Several cages were flooded, resulting in forty mouse deaths.

The Investigator followed up immediately by retraining his entire laboratory team on the proper placement of cages on the rack. Additionally, the Animal Care Program began emphasizing the proper placement of cages on racks in two required training areas, the Orientation to Animal Research training class as well as the in-person building orientation required of all staff and researchers. Per the Principal Investigator, NIH grant R01AR069653 supported the animals that were affected by this incident.


