Dear Dr. Mohapatra,

The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your April 1, 2019 letter reporting an adverse event involving research mice at the University of California- Davis. According to the information provided, OLAW understands that tail necrosis occurred in several mice due to extravasation of a cancer drug.

The immediate action taken upon discovery consisted of contacting the veterinary staff and euthanizing the mice. The protocol was amended to include the possibility of tail necrosis and consultation with the veterinary staff should this occur. The student responsible was retrained, a senior laboratory member will assist, and only lateral tail veins will be used.

Based on its assessment of this explanation, OLAW understands that measures have been implemented to correct and prevent recurrence of this problem. OLAW concurs with the actions taken by the institution tocomply with the PHS Policy on Humane Care and Use of Laboratory Animals.

Dear Dr. Wolf:

In accordance with Assurance D16-00521 # (A3433-01) and PHS Policy IV.F.3., UC Davis is bringing to your attention an adverse effect and the corrective action that occurred to mitigate future occurrences. This situation was previously reported and discussed with you over the phone with our IACUC Director, Donna Routley.

Extravasation of cancer therapeutics occurred during intended intravascular dosing, resulting in tail necrosis to a subset of affected mice. Campus Veterinary Services (CVS) veterinarians were notified and the animals euthanized. An amendment to the Animal Care and Use protocol was submitted to include tail necrosis as a potential risk of the therapeutic agents should extravasation occur during intravascular dosing, with immediate consultation with CVS should this occur again.

Also as recommended, the student, who was less experienced in tail veil injection, received additional hand-on training for intravenous injections in mice from the IACUC staff training coordinator. Additional recommendations will be followed in future experiments, including the involvement of a senior staff member who is proficient in the technique and only using the lateral tail veins for injections.
