Dear Dr. Katz,

The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your January 14, 2020 letter responding to my January 6, 2020 request for additional information regarding a reported instance of noncompliance with the PHS Policy on Humane Care and Use of Laboratory Animals at the University of California- Berkeley. According to the information provided, OLAW understands the following about the facts surrounding the provision of expired analgesic to a nonhuman primate:

- To prevent use of expired substances in animals, the laboratory will log controlled drug expiration dates in the laboratory calendar and in the surgery checklist. The dates will be checked in advance of conducting surgery.
- 2) Outdated substances are identified during the Institutional Animal Care and Use Committee (IACUC) semiannual inspection.
- No pain or distress was noted by the veterinary staff in the monkey that had received the expired drug.
- 4) The matter had been reported to the USDA. An unannounced inspection was conducted and no problems were identified.

Based on its assessment of this additional information, OLAW has a better understanding of the matter and concurs with the actions taken by the IACUC. We recommend that, if not already in place, the responsibility for ensuring use of in-date substances in animals be placed on the laboratory rather than relying only on the biannual facility inspections. Other institutions have policies in place for regular monitoring of drugs and supplies and may use color coded labels, calendars, checklists, and designated staff monitors. Thank you for keeping OLAW apprised on this matter.

Dear Dr. Wolff:

Here is our response to your request of January 6, 2020 for more information about OLAW Case A3084-2Y that was originally reported to OLAW on November 27, 2019.

- Pertaining to the corrective action plan accepted by the ACUC the Principal Investigator stated:
 "We [the lab] will log [controlled drug] expiration dates in the lab calendar and update our surgery
 - "We [the lab] will log [controlled drug] expiration dates in the lab calendar and update our surgery preparation checklists to double check expiration dates a week in advance."
- 2) UCB's ACUC conducts semi-annual inspections of all facilities and lab spaces on a regular basis. Two ACUC inspectors visited this PI's facilities and lab space on June 18, 2019 (with no findings) and again on December 10, 2019 (one tube of Neosporin was found to be expired and was thrown out immediately).
- 3) And, as documented to the ACUC in an email from one of the Office of Laboratory Animal Care (OLAC) veterinarians on November 7, 2019: "At no time before or after this administration [of Buprenorphine, expiration date 9/19] was the macaque assessed to be in pain by veterinary staff, and recovery was routine."

In addition, as you will note in the attached letter from the ACUC Chair to the Principal Investigator, UCB's AV did promptly report this incident to our USDA-APHIS VMO who noted that she would review the situation at her next visit. Subsequently, on December 18 & 19, 2019, we had an unannounced site visit by our VMO and no citations or findings were made at that visit.

If you have any additional questions, please let us know. As Institutional Official, I am satisfied that the campus has spared no resources in resolving this unfortunate incident and thereby has fulfilled its commitment to maintaining the highest standards of animal welfare, as described in our Animal Welfare Assurance.



Dear Dr. Morse:

This is to inform you regarding an animal welfare incident with one macaque that occurred at our institution.

On Tuesday November 5, 2019 a non-human primate investigator performed a minor procedure (dura scrape). At the time of the procedure Office of Laboratory Care (OLAC) staff gave Buprenorphine from the OLAC drug inventory. On the evening of November 5, the PI's staff followed up with the second dose of Buprenorphine injection (doses to be given every 12 hours) taken from the lab's drug inventory, but the PI's staff later realized the bottle they used was dated 9/2019 and thus had expired. The PI reported the incident to the OLAC veterinarians the morning of November 6 at which time the veterinarian suggested that the PI also self-report this incident to the IACUC which was done. The investigator took further action by immediately setting in place safeguards to prevent this from recurring.

This incident was discussed at the IACUC meeting held November 14, 2019 and it was determined that this was a serious noncompliance with PHS Policy on Humane Care and Use of Laboratory Animals. The PI presented a detailed plan for ensuring compliance and animal welfare in all future experiments and the IACUC accepted this plan.

The PI has informed the ACUC that the activities were performed with Public Health Service/NIH funding: 1R01MH117763-01.

As Institutional Official, I am satisfied that the campus has spared no resources in resolving this unfortunate incident and thereby has fulfilled its commitment to maintaining the highest standards of animal welfare, as described in our Animal Welfare Assurance.
