Dear Drs. Cassis, Murphy and Suckow,

The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your August 26, 2019 letter regarding noncompliance with the Public Health Service (PHS) Policy on Humane Care and Use of Laboratory Animals at the University of Kentucky, which had been preceded by a preliminary report to OLAW on July 12, 2019. According to the information provided, our office understands that a cage of mice on a PHS funded dietary study failed to be fed over a weekend. Upon discovery all mice were dead, except one which was ill and euthanized immediately.

Corrective measures by the IACUC involved counseling the principal investigator and laboratory personnel to submit a services request form for weekend care.

Based on its assessment of this explanation, OLAW understands measures have been taken to prevent recurrence of this problem. OLAW concurs with the actions taken by your institution to comply with the PHS Policy on Humane Care and Use of Laboratory Animals. Please contact our office if the corrective actions are not carried out as described. We appreciate having been informed of this matter and find no cause for further action by this office at this time.

Dear Dr. Wolff:

The University of Kentucky Institutional Animal Care and Use Committee (IACUC), through the Institutional Official, is reporting the following noncompliance and deviation from the *PHS Policy on the Humane Care and Use of Laboratory Animals* as required by section IV, F, 3a of the PHS Policy.

This incident was initially reported following a report by animal facility staff on July 12, 2019.

A cage of mice belonging to an investigator who is approved to conduct studies involving feeding a special diet contained four dead mice and one ill mouse that was immediately euthanized. Laboratory personnel had failed to provide feed to the mice over the weekend and had not requested the animal facility personnel to do so. The research staff readily acknowledged that they had forgotten to submit a services request form that would have directed animal facility personnel to provide the needed feed.

The PI and the laboratory personnel involved were reminded to use the services request form as intended, so that incidents such as this will be avoided in the future.

The IACUC believes that this action is an appropriate response to prevent similar future incidents. These studies were funded through a grant from the NIH National Heart, Blood, and Lung Institute (5R01HL107326-02).
