The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your April 16, 2020 letter reporting an instance of noncompliance with the PHS Policy on Humane Care and Use of Laboratory Animals at the University of Kentucky following up on an initial March 25, 2020 notification by email.

According to the information provided, this Office understands that the University of Kentucky Animal Care and Use Committee (ACUC) determined that instances of noncompliance occurred with respect to: a cage containing dead weanling mice. The final report states that on March 24, 2020 animal husbandry personnel found the cage of dead weanlings during regular room check. It is stated that the cage did not have a weaning card, food on the floor or a water bottle. It was determined the mice were recently weaned, but too small to reach food in the feed hopper or use the automatic watering device. Usually, a card indicating that a cage contains newly weaned mice is placed on such cages so that animal husbandry personnel can provide increased attention. In this case, no such card was placed on the cage by the PI's staff. The IACUC determined this event was a noncompliance due to incorrect weaning practices of the PI's staff resulting in the death of several mice. The IACUC is requiring the following corrective actions:

- The PI must submit for the Attending Veterinarian's approval a plan of action establishing how recurrence of weaning errors will be prevented.
- The research staff listed on the protocol must sign the remedial plan (as required in# l) as indication they understand its content and expectations.
- The PI is advised that further events of this nature will lead to transfer of all breeding colony management to the Division of Laboratory Animal Resources, at the investigators' expense.

It is noted that this projected is supported by PHS funds. Based on its assessment of this explanation, OLAW understands that the University of Kentucky has implemented appropriate measures to correct and prevent recurrences of these problems and is now compliant with provisions of the PHS Policy.

We appreciate being informed of these matters and find no cause for further action by this Office.

The University of Kentucky Institutional Animal Care and Use Committee (IACUC), through the Institutional Official, is reporting the following noncompliance and deviation from the PHS Policy on the Humane Care and Use of Laboratory Animals as required by section IV, F, 3a of the PHS Policy.

A preliminary report of this incident was made via email to OLAW on March 25, 2020.

On March 24, 2020, animal husbandry personnel found a cage of dead weanling mice during a regular room check. The cage did not have a weaning card, food on the floor, or a water bottle. The IACUC determined that this event was a noncompliance due to incorrect weaning practices of the PI's staff resulting in the death of several mice. Briefly, the mice were newly weaned, but too small to reach food in the feed hopper or use the automatic watering device. Typically, a card indicating that a cage contains newly weaned mice is placed on such cages so that animal husbandry personnel can provide increased attention; however, no such card was placed on the cage by the PI's staff.

The IACUC determined that this event was a significant noncompliance due to incorrect weaning practices resulting in the death of several mice. In response, the IACUC is requiring the following corrective actions: 1) The PI shall submit for the AV's approval a plan of action establishing how recurrence of weaning errors will be prevented; 2) The research staff listed on the protocol shall sign the remedial plan (as required in # 1 above) as indication they understand its content and expectations; and 3) The PI is advised that further events of this nature will lead to transfer of all breeding colony management to the Division of Laboratory Animal Resources,

at the investigators' expense.

The IACUC believes that this action is an appropriate response to prevent similar future incidents. These studies were funded through grants from the NIH National Cancer Institute (R01CA192894; R01CA196835)).
