Dear Dr. Ganzel,

The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your March 29, 2019 letter reporting an instance of noncompliance with the PHS Policy on Humane Care and Use of Laboratory Animals at the University of Louisville, following up on an initial report on February 27, 2019. According to the information provided, OLAW understands that mice were subjected to survival surgery although this had not been described in the approved protocol. This laboratory had been involved in previous noncompliance.

The corrective actions consisted of the Institutional Animal Care and Use Committee (IACUC) suspending the protocol. The Principal Investigator (PI) and staff were directed to take online retraining, the protocol was amended to add the surgery, the first several surgeries and post-operative care will be observed by a veterinarian and compliance specialist, and the laboratory will be subjected to enhanced post-approval monitoring by the IACUC. Upon completion of the corrective actions the suspension was lifted and the PI was warned about the consequences of future noncompliance. The NIH grant was not charged for any unauthorized animal activities.

Based on its assessment of this explanation, OLAW understands that measures have been implemented to correct and prevent recurrence of this problem. OLAW concurs with the actions taken by the IACUC to comply with the PHS Policy. Please also directly inform the NIH funding component about the suspension. Thank you for keeping OLAW apprised on this matter.

This is a final report regarding a noncompliance and IACUC proposal suspension by the University of Louisville Institutional Animal Care and Use Committee (IACUC) following a Principal Investigator's self-report of a "deviation," as defined by our "Assurance of Compliance with the Public Health Service Policy on Humane Care and Use of Laboratory Animals" (No. A3586-01). A preliminary report was submitted to OLAW on 3 March 2019.

On 6 February 2019, an investigator reported that mice were subjected to a survival surgery procedure that was not approved in the IACUC *Proposal*. The IACUC reviewed this report during its February meeting and voted to *suspend* the PI's active *Proposal* (18265) and to delay ongoing review of a modification to the *Proposal*. The IACUC formed a subcommittee to investigate the matter further. The subcommittee shared the results of their investigation and recommendations with the IACUC at its March meeting.

The subcommittee met with the laboratory during its investigation and held a training session. The subcommittee noted that the laboratory staff had recently reviewed the *Proposal* and the Principal Investigator was attentive to the matter. After discussing the subcommittee's report, and given the significance of conducting invasive research without IACUC approval and the investigator's past history of noncompliance, the IACUC decided to lift the suspension of the *Proposal* subject to the following conditions:

- Members of the laboratory must complete the following CITI training modules before any surgical techniques may be performed. All members of the laboratory are required to complete the "Working with Mice in Research Settings" and "Post-Procedure Care of Mice and Rats in Research: Minimizing Pain and Distress" modules. In addition, the Principal Investigator and any personnel responsible for surgery must complete the "Aseptic Surgery" module in CITI.
- 2. The modification to the *Proposal* to add the surgical procedure will continue through the IACUC review process. Once approved, to ensure that adequate training has been provided the first three surgical procedures performed will be observed by an RRF veterinarian and the IACUC Animal

Both will follow-up after the surgeries to train laboratory staff and ensure that post-procedural care and recordkeeping are appropriate and complete.

3. The laboratory will be subject to at least two unannounced visits by the IACUC over the next six months to ensure that they remain in compliance.

Note that records indicate this study was at least partially supported by federal funds (5UH3TR000875-05, "Fruit exosome-like particles for therapeutic delivery of extracellular miRNAs"; 1R01AT008617-01A1, "Plant exosomes non-coding RNA-mediated anti-inflammatory mechanisms").

The IACUC has reminded the PI that future incidents of non-compliance could result in limits on the laboratory's authorization to perform work with animal subjects. We believe that the IACUC's response to the incident was appropriate and will serve to safeguard animal welfare and the institution's regulatory compliance. Please note that similar reports have been filed with both USDA and AAALAC International.

Dear Dr. Morse:

This letter reports a suspension by the University of Louisville Institutional Animal Care and Use Committee (IACUC) following a Principal Investigator's self-report of a "deviation," as defined by our "Assurance of Compliance with the Public Health Service Policy on Humane Care and Use of Laboratory Animals" (No. A3586-01).

On 6 February 2019, an investigator reported that mice were subjected to a survival surgery procedure that was not approved in the IACUC Proposal. The IACUC reviewed this report during its February meeting and has formed a subcommittee to investigate the matter further. Of particular concern to the Committee was the consistency of this noncompliance with prior noncompliant behavior in 2015. Given the significance of conducting invasive research without IACUC approval and the investigator's past history of noncompliance, the Committee voted to suspend the PI's active Proposal (18265) and to delay ongoing review of a modification to the Proposal. Note that records indicate that this study was at least partially supported by federal funds (5UH3TR000875-05, "Fruit exosome-like particles for therapeutic delivery of extracellular miRNAs"; 1R01AT008617-01A1, "Plant exosomes non-coding RNA-mediated anti-inflammatory mechanisms").

We believe that the IACUC's response to the incidents was appropriate. A follow-up report will be sent to OLAW after the IACUC subcommittee completes its investigation detailing the findings and the IACUC's course of action. The UofL Office of Grants and Contracts will assist the PI in ensuring that any unauthorized costs initially billed to NIH grants will be covered by other sources. Please note that similar reports have been filed with both USDA and AAALAC International.
