Dear Dr. Locascio,

The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your October 3rd, 2019 letter reporting an instance of noncompliance with the PHS Policy on Humane Care and Use of Laboratory Animals at the University of Maryland, College Park. Your letter supplements the information provided in a preliminary telephone report on May 2nd, 2019. According to the information provided, OLAW understands that a series of non-compliance concerns related to guinea pigs left in a non-housing room for >12 hours post-operatively. These including insufficient water, overcrowding, unapproved and unskilled staff, missing or incorrect animal identification, unapproved source and breeding of animals, lack of evidence that post-operative analgesia was provided, and missing documentation related to surgery, housing, husbandry and housing. These issues were discovered during IACUC inspection of a PI-operated facility on April 3rd and April 23rd. The study was not supported by NIH funding.

Corrective actions by the institution included halting of study and immediate intervention by the Attending Veterinarian (AV) to correct animal health and welfare, suspension of two protocols by the IACUC and removal of unapproved staff. Staff retraining was conducted online via AALAS learning library consisting of 20 varied topics and face-to-face training by DLAR and the AV was conducted on regulations, general animal user training, husbandry, documentation practices, facility operations, protocol-specific concerns and regarding the role and responsibility of the PI. Additionally, the PI hired staff to assist in maintaining the facility and ensuring protocol compliance, all protocols updates (SOP, amendments) were completed, new caging systems purchased and implemented, centralized management and oversight of the facility operations including staff implemented, a permanent facility veterinarian appointed and on-going additional oversight by the Post Approval Monitor coordinator and the AV.


OLAW appreciates the prompt consideration of this matter by University of Maryland, College Park, which is consistent with the philosophy of institutional self-regulation. We understand that the institution additionally noted that USDA will be contacted to report the concern. Based on the information provided and due to the programmatic nature of the concern, a progress report describing ongoing activities as related to the non-compliance resolutions is requested to be included with the OLAW Annual report due January 31, 2020. Please ensure to identify case #A3270-1I in the documentation for ease of reference. Dear Dr. Morse:

The University of Maryland, College Park has finalized an issue that was previously self-reported to OLAW on May 2, 2019. Non-compliances related to the care and use of guinea pigs were noted during the IACUC inspection of a PI-operated facility on April 3rd and further identified during a subsequent unannounced visit by an IACUC subcommittee on April 23rd. No PHS funds supported this work.

Non-compliances

- Items associated with surgical procedures included: Animal left in non-housing room for >12
 hours after surgical procedures; no surgical, anesthesia, post-operative records available. No
 evidence that post-surgical analgesia had been administered.
- Items associated with animal housing included: overcrowding, insufficient water, unapproved/undocumented single housing, lack of enrichment for single housing, incorrect or missing animal identification, husbandry logs, and USDA records; unapproved breeding and animal source.
- Items associated with training: Staff demonstrated incomplete knowledge of pertinent documents
 and procedures including the protocol, surgical procedures, SOPs, and procedures associated with
 record keeping. Some personnel participating in animal care had not been approved by the
 IACUC for work on these animal studies.

Corrective Actions

- All animal activities within this facility were halted and animals transferred to a holding protocol.
 The Attending Veterinarian took immediate steps to correct issues related to animal health and welfare.
- Two protocols associated with the above non-compliances were suspended via a majority vote of a convened quorum of the IACUC on April 30th.
- All unapproved staff were removed from the rotation, and oversight by the Department of Laboratory Animal Resources (DLAR) was immediately put into place. This oversight remained in place during the entire period of suspension.
- Staff received face-to-face retraining by DLAR staff and the Attending Veterinarian on the following: institutional animal care and use regulations, general animal user training, general husbandry and animal care documentation, and facility operations.

- Face-to-face training was also provided on protocol-specific animal husbandry, surgical
 procedures, record keeping and post-operative monitoring. The IACUC Administrator provided
 face-to-face training regarding the roles and responsibilities of the Principal Investigator (PI).
- Online training via the AALAS Learning Library included 20 modules covering the topics above
 as well as other topics such as aseptic technique, surgical instruments and materials, working with
 controlled substances, and others. Training on the ethical conduct of research was also provided
 via an online course offered through the Office of Research Integrity, HHS.
- The Principal Investigator and staff were very cooperative throughout this process, and directly addressed questions from the IACUC.

In addition to near-term corrective actions, the following additional actions have also been taken:

- The PI hired additional staff to assist with managing the facility and ensuring protocol
 compliance and worked closely with the Attending Veterinarian and DLAR staff to bring all
 procedures and processes into compliance. All required amendments and updates to the protocol
 and SOPs have been completed.
- The department has purchased and implemented use of new animal caging. In addition, the
 department has restructured the oversight of the facility, staff and the care of the animals such
 that management is more centralized. Finally, the department has appointed a permanent facility
 veterinarian to oversee the care and use of all animals for the unit.
- The Post Approval Monitoring coordinator and Attending Veterinarian are providing ongoing additional oversight, to ensure that any issues that arise are dealt with promptly and appropriately.

On June 20, 2019, after careful consideration of corrective actions completed, and at a convened meeting of the IACUC, a majority of the quorum present voted to reinstate the two protocols associated with the non-compliances above. Ongoing post-reinstatement monitoring is in place via the Post-approval monitor, Attending Veterinarian and other DLAR staff.
