Dear Ms. Lassner,

The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your May 20, 2020 letter reporting an instance of noncompliance with the PHS Policy on Humane Care and Use of Laboratory Animals at the University of Iowa. This letter had not been preceded by a preliminary report to OLAW.

According to the information provided, this Office understands that the University of Iowa Animal Care and Use Committee (ACUC) determined that instances of noncompliance occurred with respect to: failure of lab personnel to carry out veterinary orders (e.g. treatments). The final report states on April 14, 2020 it was discovered that a lab member missed three treatments of an animal as required by the veterinary staff. It is noted the clinical veterinarian assigned to the case stated there was no animal welfare impact due to the missed treatments. Corrective actions included:

- The IACUC Training and Compliance Manager contacted the Principal Investigator (PI) and lab
 manager to discuss the issue and the lab member was provided retraining.
- On May 1, 2020 the IACUC Chair, Attending Veterinarian, and Director of the IACUC Office held a meeting with the PI to discuss the incident. As a result, the PI formed a remediation plan, including removal of animal research privileges for any lab member who does not follow veterinary orders. Reinstatement would occur once appropriate assurance is given that they fully understand and agreed to abide by their responsibilities for animal care.

The IACUC members discussed the incident at the convened meeting held on May 13, 2020. Furthermore, a meeting will be held with the PI and the Associate Dean of Research regarding the research compliance environment in the laboratory.

It is noted that this project is supported by PHS funds. Based on its assessment of this explanation, OLAW understands that the University of Iowa has implemented appropriate measures to correct and prevent recurrences of these problems and is now compliant with provisions of the PHS Policy.

We appreciate being informed of these matters and find no cause for further action by this Office.

This letter is to report an incident involving a mouse. The University of Iowa PHS Assurance Number is D16-00009 (A3021-01). The grant number affected is NS036592.

April 14, 2020: A lab member was found to have missed three treatments of an animal as required by the veterinary staff. In the professional opinion of the clinical veterinarian assigned to the case, there was no animal welfare impact due to the missed treatments.

The IACUC Training and Compliance Manager contacted the PI and lab manager to discuss the matter. Additionally, the lab member was provided retraining.

May 1, 2020: The IACUC Chair, Attending Veterinarian, and Director of the IACUC Office held a meeting with the PI to discuss the incident. The PI has formed a remediation plan, including removal of animal research privileges for any lab member who does not follow veterinary orders. Removal would be for an undetermined period and reinstatement would occur once appropriate assurance is given that they fully understand and agreed to abide by their responsibilities for animal care.

May 13, 2020: The IACUC members discussed the incident at a convened meeting and voted to report to the appropriate agencies. Additionally, a meeting will be held with the PI and the Associate Dean of Research regarding the research compliance environment in the laboratory.
