The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your April 17, 2019 letter reporting an instance of noncompliance with the PHS Policy on Humane Care and Use of Laboratory Animals at the University of Iowa. According to the information provided, OLAW understands that post-operative analgesia was being provided to mice but not as described in the approved protocol. No adverse effects were noted with the animals.

The corrective action consisted of retraining the laboratory staff.

Based on its assessment of this explanation, OLAW understands that measures have been implemented to prevent recurrence of this problem. OLAW concurs with the actions taken by the institution to comply with the PHS Policy.

This letter is to report an incident involving mice. The University of Iowa PHS Assurance Number is D16-00009 (A3021-01). The grant number affected is DC012578.

March 15, 2019: The IACUC Training & Compliance Manager (ITCM) performed an inspection of the laboratory's surgical site. During inspection it was determined from the lab's records that, although they were providing post-operative analgesia to mice, they were not providing the analgesia as described in their Animal Protocol. The ITCM provided immediate retraining. No adverse impact to the animals was reported or observed.

April 10, 2019: The IACUC members discussed the incident at a convened meeting and voted to report to the appropriate agencies.

I have reviewed the events and believe they were appropriately managed and fully addressed. I am confident that the corrective action taken will promote future compliance.
