Dear Dr. Cramer,

The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your November 7, 2019 letter reporting an instance of noncompliance with the PHS Policy on Humane Care and Use of Laboratory Animals at the University of Minnesota. According to the information provided, OLAW understands that ten chinchillas on an approved protocol were not properly monitored following recovery from anesthesia, and one animal subsequently died.

The immediate action taken upon discovery of the anesthetized animals consisted of Research Animal Resources (RAR) taking over care and monitoring vital signs. Nine chinchillas were recovered successfully and RAR staff worked with the investigators during the treatment phase and up to euthanasia. The Principal Investigator suspended all animal activities until the laboratory staff had been retrained. The Institutional Animal Care and Use Committee (IACUC) placed the laboratory under enhanced post-approval monitoring.

Based on its assessment of this explanation, OLAW understands that measures have been implemented to correct and prevent recurrence of this problem. OLAW concurs with the actions taken by the IACUC to comply with the PHS Policy.

Dear Dr. Wolff,

In keeping with the terms of our assurance, please be informed that we are making an initial report of non-compliance of an IACUC approved, NIH funded study involving chinchillas. The basis of this report results from a self-reported incident. The report outlined that ten chinchillas undergoing intra-bullar injections of bacteria were not properly monitored and recovered after anesthesia on October 30, 2019. Research Animal Resources (RAR) staff identified the problem and intervened to take over the care of the animals at which time vital signs of the animals were taken (temperature, pulse and respiration), finding that the animals had low pulses and temperatures. While animals recovered and were given additional hay to encourage eating, one animal died overnight. This animal was submitted for necropsy.

Over subsequent days, RAR supervised and worked directly with the lab during the treatment phase and euthanasia of the remaining chinchillas.

This non-compliance was reviewed by the Committee on the November 5, 2019 IACUC meeting. As such, the Committee requested that additional training be coordinated and completed with appropriate UMN specialists at the IACUC office, controlled substances, and RAR. The PI has voluntarily suspended all animal work until such training can be completed.

The Committee expects that the corrective action should prevent further non-compliance. The University of Minnesota IACUC will continue to monitor this research group and ensure that they comply with all IACUC requirements. A secondary letter will be sent once all training is completed and the Committee discusses any final steps.
