Dear Mr. Marshall:

We received your request for a variance to use your computerized record keeping system instead of APHIS forms 7006 and 7005.

The use of the (b) (4) has been approved for the USDA form 7005, 'Record of Acquisition of Dogs and Cats on Hand' and USDA form 7006, 'Record of Disposition of Dogs and Cats'. While the format has been approved, it must contain the information required in Section 2.75(a)(1) to remain in compliance with the regulations.

Presentation of the records by only a computer disk is not acceptable. In most cases, the inspector will request a hard copy to be available at the time of the inspection. He/she will have the right to observe the retrieval and printing of the records. If the inspector were unable to receive the records for proper inspection, this would be considered a violation of Section 2.126(a)(2).

Any changes to your format must be submitted to this office for approval. If the USDA develops further changes affecting record keeping, this variance may be re-evaluated to determine compliance with any new record-keeping requirement.
