Dear Dr. Chandna,

The Office of Laboratory Animal Welfare (OLAW) has completed its investigation into an allegation you submitted March 6, 2019 on behalf of the People for the Ethical Treatment of Animals to Dr. Lauer, NIH Deputy Director for Extramural Research. The matter involved the sale of live dogs by the Companion Animal Alliance (CAA) to Louisiana State University. Your concern stated that CAA was not licensed by the US Department of Agriculture (USDA) and as such the LSU purchases were in violation of the federal Animal Welfare Act (AWA). Under the Memorandum of Understanding between OLAW/NIH and USDA, we have researched this matter and have determined the following:

- In accordance with the USDA guidance document "Licensing and Registration under the Animal Welfare Act" with regard to licensing for animal sales by public shelters, "animal shelters that are part of State, county, or local governments are exempt."
- 2) CAA, although not owned by the parish, is contracted by the parish to serve as the parish's shelter.
- As such, CAA is considered to be part of the parish government and is therefore exempt from licensure requirements.
- 4) As an exempt source, CAA did not require a license to sell dogs to LSU.
- 5) There was no violation of federal law.
- 6) No further action will be taken by OLAW as there was no violation of the Public Health Policy on Humane Care and Use of Laboratory Animals.

Hi Axel - - here's a quick update.

We know that previously, LSU acquired dogs from the Companion Animal Alliance (CAA), and provided compensation to CAA in the form of donations of products, services, and possibly money. CAA is contracted by the Parish to do shelter work. If CAA transferred/sold the dogs under that contract, then the sales were not covered under the AWA as government owned/operated pounds and shelters are exempt.

CAA is also licensed with us, as they sell dogs to other entities such as rescues. If CAA transferred/sold the dogs to LSU under their USDA license, we have major concerns, as those dogs would be considered random source dogs and Congress has prohibited us from licensing dealers selling random source dogs to research. We are trying to determine what CAA's contract with the Parish includes, and what it does not include. In the meantime, it is our understanding that if CAA transfers/sells any dogs to LSU (or any other research facility), those would only be dogs that were euthanized by CAA prior to the transfer/sale, which is legal to do under their USDA license. The only other legal option involves CAA donating live dogs to LSU, and receiving no compensation of any kind, as donations with no compensation are not covered under the AWA.

That may be all you need, but if the details of CAA's contract with the Parish impacts OLAW's decision making process, let me know and I'll forward our determination once it is made.

Dear Dr. Lauer:

I write on behalf of People for the Ethical Treatment of Animals (PETA) and its 6.5 million members and supporters regarding Louisiana State University (LSU) and its practice of purchasing live dogs from Companion Animal Alliance (CAA), an animal shelter in Baton Rouge. PETA recently received information showing that CAA may have a pending USDA application to become a licensed class "B" dealer. Accordingly, we urge your office to begin investigating this matter to ensure that NIH funds are not expended on any project using such dogs, in accordance with NIH Notice Number NOT-OD-14-034.

### Background

In October 2018, PETA was contacted by a whistleblower who was the former executive director of CAA. This individual shared with PETA evidence which revealed that the shelter had sold at least 70 live dogs to LSU for use in lethal anatomy laboratories, as well as for other unknown experimental or teaching purposes. That month, PETA started submitting state open records requests to LSU to learn more about its past purchases and use of these dogs. We believe that because CAA was not licensed by the USDA, LSU's purchases were likely in violation of the federal Animal Welfare Act (AWA).<sup>2</sup> On February 6, 2019, PETA filed a formal complaint with the USDA. The USDA is currently investigating PETA's complaint.<sup>3</sup>

While it appears that the majority of the dogs supplied to LSU by CAA were used in a lethal anatomy training laboratory in the LSU School of Veterinary Medicine, internal emails obtained by PETA reveal that at least some dogs were also used "by other departments" for unknown experimental or teaching purposes. PETA submitted a records request for simply the *titles* of any animal use protocols for projects utilizing shelter-sourced dogs, but LSU refused to release this information.

### CAA's Application for Class "B" Dealer License

Recently, new records were provided to PETA that show that on December 6, 2018, while a PETA open records request was pending, CAA applied for a class "B" dealer license from the USDA. This license would allow CAA to begin *lawfully* selling "random source" live animals to LSU (and other research facilities) for use teaching or experimentation. On December 21, 2018, the USDA responded to CAA's application, providing CAA with the Customer ID Number 505239, and explaining the next steps of the licensing process. A USDA inspector appears to have been assigned the task of arranging a pre-licensing inspection, the next step in issuing CAA a class "B" dealer license.<sup>6</sup>

According to publicly accessible information in NIH's RePORT database, in Fiscal Year 2018, LSU received 162 NIH awards, for a combined total funding amount of more than \$54 million. Just earlier this month, the NIH and LSU announced that LSU's School of Veterinary Medicine was being awarded \$11.5 million to establish a pulmonary research center. As you are likely aware, NIH policy prohibits any awarded funds from being expended on a project which utilizes dogs procured from class "B" dealers. As of this date, it is unknown what projects or experiments at LSU intend to utilize dogs purchased from CAA, were it to become a licensed class "B" dealer. LSU has refused to publicly release this information. But given the size and scope of the NIH-funded activity at LSU, and its veterinary school in particular, PETA is gravely concerned that LSU may be running afoul of NIH policy.

PETA is writing to urge the NIH to suspend future awards and grants to LSU until the agency can conduct an inquiry with LSU to determine how and when the university intends to use dogs purchased from class "B" dealers, to ensure that NIH funds do not touch any of these projects.

Thank you for your prompt attention to this matter. I look forward to hearing from you, and I am able to assist your investigation in any way possible.
