Dear Dr. Tornquist,

The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your March 9, 2018 letter reporting an incident of noncompliance with the PHS Policy on Humane Care and Use of Laboratory Animals at Eastern Michigan University. According to the information provided, OLAW understands that on March 8, 2018 a PI continued to conduct research using mice after protocol expiration. The PI had been sent a reminder but did not submit a renewal application. The remaining mice are currently under a different IACUC-approved protocol. It is further understood that the animal activity was not funded by the PHS.

Corrective and preventive actions included the PI renewing his protocol approval and instituting a calendar-tracking measure to better keep track of protocol annual reviews and three-year de novo reviews.

OLAW believes that the corrective and preventative measures put in place by Eastern Michigan University are consistent with the provisions of the PHS Policy on Humane Care and Use of Laboratory Animals. Although this activity was not PHS funded, the application of the standards of the PHS Policy across the animal care and use program reduces any potential appearance of a double standard. We appreciate being informed of this issue and find no cause for further action by this office.

Dear Dr. Wolff,

This letter represents a report of noncompliance at Eastern Michigan University under assurance number A3899-01. The incident qualifies for reporting under PHS Policy IV.F.3.b: a serious deviation from the provisions in the Guide.

On Thursday, March 8, 2018, the Eastern Michigan University Office of Research Compliance discovered that one of our principal investigators had allowed his IACUC approval to lapse and was conducting research using mice without current IACUC approval. The principal investigator had been sent a reminder but did not respond with a renewal application. The mice used under the lapsed protocol are currently under a different IACUC-approved protocol.

The corrective action plan consists of the following:

- 1. The principal investigator is not conducting research with mice until approval is renewed.
- 2. The principal investigator is renewing his IACUC approval.
- 3. The Office of Research Compliance has instituted new measures to better track IACUC protocols. Upon approval, the Research Compliance Officer enters reminder notices into her calendar to provide notification for annual review and the threeyear de novo review. Notification will continue weekly until the annual report/de novo application has been received.

All provisions of the corrective action plan have been implemented on the date of this notice

The research conducted using these mice is unfunded. Therefore, there is no effect on PHSsupported activities.

Eastern Michigan University is committed to ensuring ethical care of all animals used in research and teaching. Any additional guidance from OLAW in these matters would be
