SUBJECT: Spring 2020 Semi-annual Facility Inspection and Program Review Reports

Our Institution adheres to the recommendations of the Guide, the PHS Policy, and the Animal Welfare Act and Regulations, all of which are used as a foundation for the development, implementation, and continual improvement of a comprehensive animal care and use program based on humane care and use of animals.

As a result of the coronavirus outbreak, the facility inspections were conducted using Measures outlined in NIH/OLAW NOT-OD-20-088 were implemented to perform these inspections by qualified individuals/ad-hoc consultants including a facility manager and Principal Investigators. The OLAW Semi-annual Facility Inspection Checklist (based on the 8th Edition *ILAR Guide for the Care and Use of Laboratory Animals*) was used as a guideline. The following definitions were used to determine the categories of compliance: A= acceptable; met or exceeded USDA and NIH standards; M= minor deficiency; items not affecting animal health or safety; S= significant deficiency (items that are or may be a direct threat to human or animal health and safety where animals are involved in the research); C=Change which will be submitted to OLAW; N/A=Not applicable. There is a list of minor deficiencies found during these inspections and which are outlined in the attached documents. These reports were discussed and approved by the IACUC at their meeting on May 11, 2020.

Additionally, the IACUC reviewed and approved the program review at the convened meeting on April 13. 2020. The OLAW Semiannual Program Review Checklist based on the 8th Edition of the ILAR Guide for the Care and Use of Laboratory Animals was used as a guideline. As

reported before there remains an ongoing concern. The components of the occupational health and safety program for medical evaluation and preventative medicine for those working with vertebrate animals are in place however, the IACUC requested better monitoring and adherence to the program due to an increased number of gaps in documentation. Additionally, the IACUC recommended moving from a paper-based system to an electronic monitoring system to accommodate more efficient and effective compliance as well as future growth in the use of animals. A letter has been sent to EH&S Senior Director outlining the IACUC's concerns.

There have not been any departures from the regulations submitted, reviewed and/or approved over the last 6 months.

These inspections took place, as per the regular schedule, after the University closed due to the COVID-19 pandemic. Measures outlined in NIH/OLAW NOT-OD-20-088 were implemented to perform these inspections by qualified individuals/ad-hoc consultants including a facility manager and Principal Investigators.

The SDSU Office of Laboratory Animal Care and Principal Investigators continue to care for the animals being housed and used in research by perform normal husbandry, health checks and notifications to the PI, as necessary. No USDA covered species are being housed.

- The inspections for OHS requirements were conducted by the Veterinarian using the OLAW recommended facility inspection checklist.
- Controlled substance inspection is in progress. The duty has been assigned to another person in EH&S.
- Throughout all applicable facilities and rooms, CO2 rates will be recalculated and posted to meet the requirements of the 2020 AMVA Guidelines for Euthanasia. The posted flow rates will include brief

instructions for lab owned CO2 euthanasia chambers.

Housing started at this satellite facility on March 29, 2020.

The chicken coop at the facility has ample space for the two sets of five chickens (10 total). The entire chicken coop was physically split in half with wire mesh. On the interior of the chicken coop each set of five chickens are housed in approximately 60 ft.2 of space. In addition to the interior space the chickens also have an outside protected run. Each half of the outside run also has approximately 60 ft.2 of space. Each half of the internal space has a 5 gallon container for water (2 total), an approximately 4 gallon container of food (2 total), a heat lamp (2 total), and perches/roosts for all 10 chickens.

The chickens are checked on at minimum once per day, but more often than not, two to three times per day. All 10 chickens are quite healthy and are continuing to grow very robustly. Even though the water containers hold 5 gallons of water (and thus would only need to be filled approximately once per week), the PI has been continuing to use and add fresh water to the small water containers. The content of the food containers is monitored on a daily basis, as well as the large water containers. The large water containers are normally dumped and cleaned with soap and water approximately every third day. The diets of the chickens have been enhanced with dry mealworms, as well as a product purchased off Amazon.com and referred to as "Chick Sticks".

Records of the daily care for the chickens in a chicken husbandry log book. Because of the age of the chickens, as well as the less than optimal weather conditions they've been experiencing in March and April, the PI only allows the chickens into the outside run once per day for approximately 30 minutes. As the chickens become older, and the weather becomes more optimal, the doors to the outside chicken run we'll be opened in the mornings, and then closed again in the evening (unless the weather becomes very warm and then the chickens will have access to the outside run 24 hours per day).

Assurance Changes after OLAW site visit on January 29, 2020 has been submitted to OLAW.

Program Changes Since the Last Semi-annual Program review in October 2019:

- Components of the occupational health and safety program for medical evaluation and preventative medicine for those working with vertebrate animals are in place however, the IACUC requested better monitoring and adherence to the program due to an increased number of gaps in documentation. Additionally, the IACUC recommended moving from a paper-based system to an electronic monitoring system to accommodate more efficient and effective compliance as well as future growth in the use of animals. A letter has been sent to EH&S Senior Director outlining the IACUC's concerns in October 16, 2019. The Program has been revised however a plan for implementation is still needed.

 - Blood Collection Rodent Re-review
 - Blood Collection Intracardiac Re-review
 - o Rodent Non-Survival Surgery Guidelines Re-Review
