This report summarizes the IACUC's results of its most recent program review and facility inspection, as required by the Public Health Service (PHS) Policy on Humane Care and Use of Laboratory Animals (<u>Policy</u>), Section <u>IV.B.1.-3.</u>, the *Guide for the Care and Use of Laboratory Animals* (<u>*Guide*</u>), and the Animal Welfare Act (<u>AWA</u>) regulations, as applicable.  - The sub-committee noted concerns with regard to the post approval monitoring process. The primary concern regarded the methods used for tagging and sharing monitoring protocols. Dr. Schuler and

 (b) (6) met on Monday, September 16, 2019, to discuss the process of handling monitoring in a conducive manner.
 - 3. The sub-committee discussed the issue of designated sinks, located on the 2nd floor of the Medical Sciences Building (MSB). It was determined that the sinks should be capped. It was also determined that Gavin Guy would handle the capping of the sinks, and submit a report to the IACUC chair. The Chair will present the findings to the IACUC committee at the 11/21/19 meeting.

- 4. The sub-committee discussed the multiple failings of the HVAC system, located in the Vivarium. None of the HVAC failures resulted in harm to the animals. Also temperatures were maintained by Vivarium personnel moving in portable HVAC units. The course of action is to continue monitoring and report system failures to the Chair & Institutional Official (IO). If the situation becomes critical, and no external funding is provided, then the Chair, Vice-Chair, and Attending Veterinarian will meet with the Institutional Official (IO) to discuss.
- 5. The sub-committee reviewed the IACUC's required training and determined that training was sufficient. It was noted that additional training was initiated by the Department of Comparative Medicine (DCM) and designated staff/personnel attended AALAS seminars and OSHA conference on Veterinarian Practice.


