Dear Dr. Bonnell,

The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your June 10, 2020 letter reporting an instance of noncompliance with the PHS Policy on Humane Care and Use of Laboratory Animals at the University of Pennsylvania. This letter had not been preceded by a preliminary report to OLAW.

According to the information provided, this Office understands that the University of Pennsylvania Animal Care and Use Committee (ACUC) determined that instances of noncompliance occurred with respect to: failure to adhere to the IACUC-approved protocol. The final report states that the research team did not monitor nor remove rear leg bandages on 3 laboratory mice as per protocol. It is stated the lack of monitoring and removal of bandages contributed to a medical adverse event. As a result, the mice were humanely euthanized and the vet staff and IACUC were informed of the issues by the principal investigator (PI). To avoid future recurrence, the PI agreed to: retraining the staff, enhancing the monitoring and lengthening the monitoring period. Also, a more vigorous documentation practice was adopted which includes confirmation of bandage actions.

It is noted that this research is supported by PHS funds. This Office assumes that the IACUC approved the corrective action plan. Based on its assessment of this explanation, OLAW understands that the University of Pennsylvania has implemented appropriate measures to correct and prevent recurrences of these problems and is now compliant with provisions of the PHS Policy. We appreciate being informed of these matters and find no cause for further action by this Office.

Dear Dr. Morse,

The University of Pennsylvania is reporting an adverse event that affected the well-being of three laboratory mice on an IACUC approved skin research project. The research team did not monitor nor remove a rear leg bandage as per protocol which contributed to a medical adverse event. When the medical issue was noted, the mice were humanely euthanized and the veterinarian staff and IACUC were informed of the issues by the PI. To avoid future incidents, the PI agreed to retrain the staff, the monitoring was enhanced, and the monitoring period lengthened. Additionally, a more robust documentation practice was adopted which includes confirmation of bandage actions. The grant was funded by NIH 5 K08 AI 130365 02.
