Dear Dr. Larsen,

The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your March 10, 2020 letter reporting an instance of noncompliance with the PHS Policy on Humane Care and Use of Laboratory Animals at the University of Nebraska Medical Center (IACUC Case #2019-06). According to the information provided, OLAW understands that two incidents occurred wherein a lab failed to use aseptic technique and preform post-operative monitoring of mice. Upon review of the incidents by the IACUC, the PI voluntarily stopped all procedures. The related animal activity was PHS funded.

Corrective actions included the IACUC requiring all assigned research personnel involved in rodent survival surgery to complete the Aseptic Rodent Surgery course and have their proficiency evaluated by veterinary staff. Continuous assessment would be conducted by the veterinary staff and the Protocol Assessment Liaison who would report back to the IACUC. The IACUC also required the PI to appoint a Laboratory Animal Coordinator (LAC) who, after proper training, would be responsible for oversight and monitoring all animal protocol activities and training for the lab. The LAC would also serve as liaison between the lab, Comparative Medicine and the IACUC, sharing opportunities for education and ensuring compliance in all research activities.

The prompt consideration of this matter by the University of Nebraska Medical Center was consistent with the philosophy of institutional self-regulation. Similarly, the completed and in-process actions taken to resolve the issues and prevent recurrence were appropriate. OLAW concurs that the incident warranted reporting. We appreciate being informed of this matter and find no cause for further action by this office.

Dear Dr. Wolff:

I am submitting this report in accordance with the requirements of the PHS Policy at IV.F.3. The IACUC has reviewed this incident described in this report determined it was reportable to OLAW.

- 1. Animal Welfare Assurance Number: A3294-01
- 2. Grant or Contract Number: NIH 5R01CA216853-03
- 3. Species: Mice
- 4. Effects on Programmatic or Physical Areas: N/A
- 5. Explanation of the Situation:
  - a. There were two instances in which research personnel used improper aseptic surgical technique, and did not follow their approved protocol for post-operative monitoring of mice. The mice were in good health after the first occurrence, but on the second occurrence, veterinary intervention was required.
  - b. The Post Approval Liaison (PAL) was promptly notified and met with the Principal Investigator and the research personnel that performed the procedure and post procedural care to discuss the incident and the discrepancies from the approved protocol. A repeat incident occurred following the initial meeting with the PI and research personnel but prior to re-training. An IACUC subcommittee meeting was held the same day as but after the second incident.

## 6. Actions Taken by the IACUC:

a. The IACUC Subcommittee reviewed the incidents on December 20, 2019 and on January 16, 2020. The full IACUC reviewed the incident on February 19, 2020. The investigator agreed to discontinue all procedures until research personnel were retrained and their competency confirmed. The IACUC will continue to monitor laboratory activities by conducting regular audits after the personnel are approved to resume activities. The committee required that all research personnel assigned to perform, or

Veterinary staff will assess the proficiency of each person before they are allowed to perform procedures independently. The committee also implemented continuous monitoring by CM veterinary staff and the Protocol Assessment Liaison (PAL), who will provide the IACUC with progress reports at FC meetings

b. The committee also required that the PI designate one person to serve as the Laboratory Animal Coordinator (LAC) once they are certified to perform survival surgery. The responsibilities of the LAC are as follows: 1) to complete a series of LAC training modules as determined by the IACUC, 2) be responsible for daily oversight and monitoring of all approved animal protocol activities and provide training as needed to laboratory personnel, and 3) serve as the liaison between the lab and CM and the IACUC, sharing opportunities for education and ensuring compliance in all research activities.
