The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your January 23, 2018 letter reporting an adverse event at The University of Toledo. According to the information provided, OLAW understands that ringtail was identified in six litters of rat pups and one litter had to be euthanized as a result of humidity levels falling below 30%, as recommended in Guide for the Care and Use of Laboratory Animals. Apparently this is the second winter that The University of Toledo has experienced this incident.

The corrective actions consisted of providing veterinary care to the affected animals, the Department of Laboratory Animal Research (DLAR) working with The University of Toledo Facilities staff to increase humidity levels in the vivarium, housing rats with ringtails in static cages with lids instead of ventilated caging in an attempt to increase the humidity concentrations within the cage microenvironment and providing updates to the Institutional Official as warranted.

Based on the information provided, OLAW is satisfied that appropriate actions have been taken to investigate, correct and prevent recurrence of the noncompliance. We appreciate being informed of these matters and find no cause for further action by this Office.

Dear Dr. Wolff:

The University of Toledo (UT), in accordance with Assurance A3414-01 and PHS Policy IV.F.3., provides this report of continuing noncompliance regarding an incident animal areas reporting humidity levels below 30% resulting in animal welfare issues, reported to the IACUC on January 10, 2018.

In December 2017, several animal housing areas have reported humidity levels below the *Guide's* standard of 30%. Some of these areas are reporting ringtail in rat pups. So far, six litters of pups have presented with lesions and one litter has had to be euthanized. This is the second winter this issue has occurred in the vivarium. The following corrective actions have been put into place:

- Veterinary staff are treating the ringtail as it occurs.
- DLAR staff are working with UT Facilities to increase overall humidity in the vivarium.
 Additionally, those rats in ventilated cages presenting with ringtail have been moved to static cages and those in static cages have had lids placed in attempts to increase within cage humidity.
- The IACUC and DLAR will keep the IO informed as to the status of the facilities' ongoing humidity level and the status of the ringtail.
