APPENDIX A

All major changes made to the Assurance of Compliance with the PHS Policy during 2018:

- The authority for the Institutional Official (IO) was delegated to the Associate Director for Laboratory Science and Safety (ADLSS), effective March 14, 2018, superseding the previous delegation of authority (February 8, 2011) to the Deputy Associate Director for Science, Office of the Associate Director for Science.
- CDC completed a reorganization, effective October 1, 2018. With this reorganization, the Animal Care and Use Program Office (ACUPO) moved from the Office of Science (OS, formerly the Office of the Associate Director for Science (OADS) to the Office of Laboratory Safety (OLSaf) within the Office of Laboratory Science and Safety (OLSS, formerly the Office of the Associate Director for Laboratory Science and Safety (OADLSS).
- The Comparative Medicine Branch is actively recruiting to fill a vacant Senior Clinical Veterinarian position.
- Electronic submission through the Safety Helpdesk ticket system was added as an additional anonymous mechanism to report animal welfare concerns.
