-A hole about five inches wide is noted in one of the wire cages. The hole is large enough for the entire head and neck of a rabbit to pass through and may cause injury should the rabbit attempt to escape. Facility shall ensure that housing facility is structurally sound and maintained in good repair.

3.52 (e) Drainage.

-Large pools of blackish water mixed with fecal materials under rabbit cages are noted in the barn. Barn do not have adequate drainage to channel excess water from the barn. Standing water may provide growth for harmful organisms. Facility shall ensure that a suitable method be provided to rapidly eliminate excess water from the barn.
