Dear Registrant:

This letter is to inform you that, because you did not respond to our letter dated 05/15/2019, regarding the failure to renew your USDA registration by the cancellation date of 03/17/2019, and because we did not receive your Animal Welfare Act (AWA) registration update documents before the stated cancellation date, your USDA registration # 21-R-0207, has been cancelled. To operate as a research facility without a valid registration is a violation of the Animal Welfare Act; those who do so are subject to prosecution.

If you have allowed your registration to lapse and are no longer conducting regulated activities, please be advised that you must apply for, and be issued a new registration before conducting any regulated activities.

Since you are registered as a research facility, we wish to emphasize that all research facilities must file an annual report (APHIS form 7023) with the Animal Care regional office documenting their activities and animal usage for the Federal fiscal year (October 1 through September 30) by December 1 of that year. A research facility whose registration was terminated during the fiscal year must also fulfill this requirement; failure to do so constitutes a violation of the AWA and its regulations. Enclosed, please find a copy of APHIS form 7023. Please complete the form and return it to our office. Instructions are enclosed with the report.
