All regulated animals appeared healthy during the inspection. All were in good body condition. None						
were dehydrated. All animals had access to water and food as required by the Animal Welfare Act.						
IACUC records reviewed and discussions with OAWA staff did not identify any regulated animals that						
were crushed in a trash compactor or died due to improper anesthetic use.
