Dear Dr. Wang,

The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your January 15, 2019 letter reporting an instance of noncompliance with the PHS Policy on Humane Care and Use of Laboratory Animals at the Center for Comparative Physiology at the Feinstein Institute for Medical Research. According to the information provided, OLAW understands that following surgery, five mice were found with dehiscence of the incision site. Post-operative monitoring had not been conducted by the laboratory staff as described in the approved protocol.

The corrective actions consisted of the veterinarian directing the investigators to use enhanced local and systemic analgesics, to apply a more secure surgical closure, and to amend the protocol to reflect this. The laboratory was placed under enhanced post-approval monitoring. If laboratory staff cannot conduct the post-operative monitoring then central facility technicians can perform this task.

Based on the information provided, OLAW is satisfied that appropriate actions have been taken to investigate, correct, and prevent recurrence of the noncompliance. OLAW assumes the affected mice were treated or euthanized. We appreciate having been informed about this matter and find no cause for further action by this Office.

Dear Dr. Wolff:

I am writing to inform the Office of Laboratory Animal Welfare of an incident of serious non-compliance that occurred at the Center for Comparative Physiology (CCP) at the Feinstein Institute for Medical Research. While the research in question is not federally funded we are reporting this as non-compliance under the terms and conditions of our federal assurance.

A surgical procedure was performed on mice on 12/12/18. Post-operatively, 5 mice were found by facility staff with dehiscence of the incision area. Remaining cohort were stable. After investigation of the incident, it was determined that post-operative monitoring was not conducted by study personnel in accordance with the approved protocol. Consultation with the veterinarian resulted in recommendations for enhanced local and systemic analgesics as well as a more secure incision closure.

Corrective Actions:

- Increased post-approval monitoring for this protocol, specifically, the next cohort of surgical animals.
- Program resources are available to mitigate this issue. If study personnel are incapable of providing post-procedural monitoring of animals
 as described in the protocol, they may contact the CCP Director in advance to arrange for technical assistance.
- Modification to be made to the protocol for enhanced local and systemic analgesics as well as a more secure incision closure.
