Dear Dr. Koker,

The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your June 5, 2018 letter reporting noncompliance with the Public Health Service (PHS) Policy on Humane Care and Use of Laboratory Animals (Policy) which was preceded by a preliminary report via telephone on February 21, 2018. The letter indicated that it was discovered that official IACUC business requiring a quorum (full committee review of an activity in accord with PHS Policy IV.C.2) occurred in the absence of a quorum at the University of Wisconsin-Oshkosh on August 29, 2017. It was determined that this incident occurred due to an oversight where the total number of IACUC members had not been recalculated upon the Chair's return from sabbatical in conjunction with review of a protocol renewal and a protocol modification with one recused IACUC member. The associated work was not PHS funded.

Corrective actions included the review and approval, in a manner consistent with PHS Policy, of the animal activities that had previously been approved with the lack of a quorum. Preventive measures include a plan to list committee member names at the top of the meeting agenda with the number required for quorum to ensure that quorum can be confirmed in a quick and easy manner for all future full committee meetings. This incident and plan was discussed and accepted by the IACUC on May 24, 2018.

Although the associated animal activity was not PHS funded, there was the potential for this incident to have affected animal activity with any funding source. The reporting of this incident reinforces the underlying foundation of the PHS Policy which is that of institutional self-evaluation, self-monitoring, and self-reporting. OLAW commends the vigilance of the University of Wisconsin-Oshkosh IACUC and appreciates your institution's commitment to protecting the welfare of animals used in research. OLAW concurs with the corrective and preventive actions and finds no cause for further action by this Office. Thank you for informing OLAW of this matter.

UW Oshkosh, in accordance with Assurance D16-00342 and PHS Policy IV.F.3., provides this final report of noncompliance regarding an incident in which quorum was not maintained for parts of the August 29, 2017 IACUC meeting. A preliminary report was submitted on February 21, 2018 via telephone to Dr. Na in the OLAW Division of Compliance Oversight by

Incident Description:

During an IACUC record review in preparation for the AAALAC site visit, ^{(b) (6)} noticed a discrepancy in the number of IACUC members recorded in the minutes (August 29, 2017 & December 7, 2017) and the number on the current IACUC roster. Looking into it further, it was realized that the Chair had not been recalculated into the total number of members following her return from sabbatical and we had a total of 10 members. A quorum was maintained for the December 7, 2017 meeting with 7/10 members but quorum was not maintained for parts of the August 29, 2017 meeting.

A quorum was not maintained for voting on three items during the August 29, 2017 meeting:

1) Minutes from May 1, 2017 meeting,

2) 3 year renewal of Protocol 250-R2 in which PI/IACUC member Kurtz recused herself, and

3) Modification to Protocol 233-R2 to change the euthanasia method in which PI/IACUC member Kurtz recused herself

^{(b) (6)} called OLAW on February 21, 2018 when the quorum issue was discovered and spoke to Dr. Na to see if the event was reportable given that the protocols were not PHS or NSF funded. No work had been conducted under Protocol 250-R2. In addition, the modification to euthanasia method requested in Protocol 233-R2 had not been implemented yet. Dr. Na indicated that the incident should be reported to OLAW since it falls under a program wide concern and took the preliminary report over the phone.

IACUC Recommendation/Preventive Plan:

A copy of the incident was shared with the IACUC via email on February 21, 2018. A subset of the IACUC met on April 5, 2018 and discussed the incident. It was determined that the minutes from the August 29, 2017 and December 7, 2017 meeting will be revised to reflect the correct number of IACUC members and be placed on the next convened meeting agenda for approval by the committee. Protocol 250-R2, Protocol 233-R2 modification request, and the May 1, 2017 minutes would be re-reviewed by the IACUC. In the future, the committee member names will be listed at the top of the

meeting agenda along with the number required for quorum to ensure that quorum can be confirmed in a quick and easy manner. All items that needed IACUC review were sent back to the IACUC and approved as indicated below:
