Dear Dr. Ramasubramanian,

The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your June 18, 2020 letter reporting an instance of noncompliance with the PHS Policy on Humane Care and Use of Laboratory Animals at the University of Virginia, following up on an initial report on April 16, 2020. According to the information provided, OLAW understands that four live mice were found among carcasses in a procedure room due to a failure to ensure death by a secondary physical method following exposure to CO2 for euthanasia.

The immediate action taken upon discovery consisted of appropriately euthanizing the mice. The individual responsible could not be identified therefore all investigators housing mice in the vivarium were retrained. The investigators and animal handlers were retrained on appropriate methods of euthanasia and on confirming death. The training was documented.

Based on its assessment of this explanation, OLAW understands that measures have been implemented to correct and prevent recurrence of this problem. OLAW concurs with the actions taken by the institution to comply with the PHS Policy. Please remember, as Institutional Official, to sign all final reports of noncompliance to this Office. Thank you for keeping OLAW apprised on this matter.

University of Virginia Animal Welfare Compliance Report

PHS Assurance # A3245-01

A preliminary email notification was sent to the OLAW Division of Compliance Oversight by Angela Gamble, Director of the Office of Animal Welfare. Dr. Axel Wolff acknowledged receipt. It was understood that a full report would follow IACUC investigation. This document is a summary of the incident, actions taken, and final resolution.

UVA Compliance Case #: 2020-E

Nature of Incident(s):	Failure to ensure death of animals after euthanasia procedures (mice)
Summary of Incident:	The husbandry staff discovered that a researcher failed to ensure the death of four animals following CO ₂ euthanasia. The four alive animals were found with other mouse carcasses in a procedure room used for CO ₂ euthanasia. The four animals were immediately euthanized by the husbandry staff.
Action taken by IACUC:	At the next convened monthly meeting, the IACUC reviewed the information gathered by the Office of Animal Welfare which determined that the laboratory responsible for the event could not be identified with absolute certainty. Due to the significant impact on animal welfare, the IACUC mandated retraining for all researchers housing mice in the specific vivaria at the time of the incident.
	Thirty two researchers (PIs) were provided a training document describing the accepted methodologies for performing a secondary physical method for confirming death in mice that have been euthanized following CO ₂ inhalation or anesthetic overdose. Each PI received individualized training documents containing a list of animal handlers requiring retraining. Additionally, the IACUC policy on euthanasia, confirmation of death, and carcass disposal was provided and included for retraining. Upon retraining completion, each PI was asked to resubmit the training document indicating which animal handlers were retrained and signify completion with their own signature.
	All of the PIs submitted the signed documentation as required.
Decision/Resolution:	The IACUC felt that no further action was deemed necessary and considered the incident resolved.
Federal Funding:	This was considered to be an isolated issue but had the potential for affecting funded research animals.


