The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your April 15, 2019 letter responding to my April 8, 2019 request for additional information regarding a suspension of animal activities at the University of Wyoming. According to the information provided, OLAW understands the following:

- 1) The Attending Veterinarian (AV) noted several problems in a laboratory conducting rat surgery including inadequate surgical recordkeeping, protocol deviations involving anesthetics/analgesics, failure to use aseptic technique and sterilize equipment, and inadequate conditions for rats recovering from surgery. All of the investigator's protocols were suspended by the Institutional Animal Care and Use Committee (IACUC), including one NIH-supported one.
- 2) NIH had not been notified about the suspension because the problems found in the laboratory were not associated with the NIH supported protocol.*
- Monthly post-approval monitoring by the AV subsequently found that all deficiencies had been corrected and that no new problems had occurred.
- 4) All laboratory staff has been retrained on aseptic technique and surgery. No new surgeries have been conducted since the suspension, but once they resume the AV will observe the staff for proficiency. Records will also be audited monthly by the AV.

Based on its assessment of these explanations, OLAW has a better understanding of the original deficiencies which prompted the suspension as well as the measures taken to correct and prevent recurrence. OLAW concurs with the actions taken by the institution to comply with the PHS Policy on Humane Care and Use of Laboratory Animals. *Please note that the NIH funding component must be notified of the suspension even if the supported protocol did not have any animal welfare problems. Suspension constitutes a serious institutional/IACUC action and requires reporting to OLAW, USDA (if covered species are involved), and any federal agency funding the activity. Thank you for keeping OLAW apprised on this matter.

The University of Wyoming has received your April 8, 2019 letter regarding Animal Welfare Assurance A3216-01 [OLAW Case J] and the request for additional information. We are happy to clarify on the points highlighted herein.

1. Describe the initial noncompliance noted by the AV which led to the protocol suspension. The researcher contacted the AV for a refill of medications on one of their protocols. The AV decided to stop by to drop off the medication and pay a site visit at the lab. Upon arriving, the AV noted immediate and serious concerns, including: poor documentation of surgical procedures and related animal welfare record keeping; protocol deviations related to techniques as well as analgesic and anesthetic usage; improper or insufficient aseptic techniques and equipment sterilization; and insufficient recovery conditions for rats recovering from surgery. These collective errors and oversights were brought to the attention of the IACUC who determined that the best course of action was to suspend all rat protocols by the investigator until sufficient appropriate steps could be taken to remedy all of these issues. While several protocols were suspended, only one was NIH-funded, but there were no direct animal welfare concerns found on that protocol.

Indicate whether the suspension was reported to the NIH funding component.
 Because none of the aforementioned violations were directly associated with the NIH-funded protocol, neither NIH nor INBRE were formally notified following the discovery, ruling, and follow-through made by the IACUC, aside from our OLAW reporting.

Provide an update on the findings of the PAM visit.

The AV has made random monthly inspections of the laboratory and surgical areas to ensure that all noted deficiencies have been corrected and continue to the meet IACUC's expectations. So far, all requested improvements have been made and the AV has not found any signs of recidivism.

4. Provide an assessment of the current proficiency of the research staff and the quality of the record keeping.

All lab personnel have attended a supplemental training session on aseptic technique and the surgeries utilized in their lab. This session was taught by a highly-qualified MD/PhD from another lab group, and the training was observed by the AV. To date, no surgical procedures have occurred since the suspension, so no observation of surgeries by the AV have taken place to evaluate the additional training that the researcher and their lab personnel have taken to improve surgical technique and/or monitoring. When the researcher begins performing surgeries again, the AV will observe until the IACUC is satisfied that procedures are conducted following AVMA guidelines and as trained during the remediation. Monthly inspections of the breeding and lab notebooks have been carried out by the AV to ensure accurate and regular recordkeeping of animal care activities, as well as adequate PI oversight of records. The research staff has greatly improved their recordkeeping, and the AV will continue to frequently monitor this until the IACUC is satisfied

The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your March 12, 2019 letter reporting the suspension of specific animal activities at the University of Wyoming, following up on an initial telephone report on November 1, 2018. According to the information provided, OLAW understands that the Institutional Animal Care and Use Committee (IACUC) took this action following a report of concerns by the veterinarian regarding some rat studies.

In addition to the suspension, the IACUC required hands-on and online retraining of the laboratory staff. The laboratory was placed on enhanced post-approval monitoring (PAM), the IACUC reviewed animal care records and will audit these monthly, the Attending Veterinarian (AV) will observe surgeries and euthanasia, and the AV will assess surgical proficiency when new procedures are planned.

In order for OLAW to have a complete understanding of the facts in this case, please provide the following additional information:

- Describe the initial noncompliance noted by the AV which led to the protocol suspension.
- 2) Indicate whether the suspension was reported to the NIH funding component.
- 3) Provide an update on the findings of the PAM visit.
- 4) Provide an assessment of the current proficiency of the research staff and the quality of the record keeping.

The University of Wyoming, in accordance with Assurance D16-00135 (A3216-01) and PHS Policy IV.F.3., provides this report of noncompliance regarding an incident funded on NIH NIGMS Wyoming INBRE 2P20GM103432-17 (Project date September 10, 2018 to April 30, 2019). This incident was reported to you via phone on November 1, 2018 by Dr. Carolyn Broccardo, Director of Research Integrity and Compliance at UW. Below is a summary of the situation.

A researcher contacted the UW attending veterinarian (AV) for a refill of medications on a different protocol. The AV decided to stop by the laboratory and noted several concerns. Based on these concerns, the IACUC decided to suspend all protocols by the PI involving rats. One of the suspended protocols was NIH-funded, but there were no direct animal welfare concerns found on this protocol.

Species: Rattus norvegicus

Category of personnel involved: Faculty, graduate student

Dates: Fall 2018Animal deaths: 0

The IACUC and the UW Research Office discussed the incident and agreed upon a corrective action plan. The PI expressed remorse for this incident and took responsibility for the noncompliance and assured the IACUC that an incident of such nature would not occur again. The IACUC determined that this was an isolated incident and not a programmatic failure.

The following corrective action plan has been completed:

- All lab personnel associated with animal work on the affected protocol took a hands-on workshop in general rodent research techniques and surgery, which was accompanied by the AV.
- All personnel re-took the relevant CITI courses, including: Working with the IACUC, Aseptic Surgery, Post Approval Monitoring, Working with Mice in Research, Working with Rats in Research, and Working with Sheep and Goats in Research Settings.

The following corrective action plan will continue to be upheld:

- Monthly and random lab inspections of laboratory and surgical area by representatives of the IACUC.
- Initial review by representatives of the IACUC of all laboratory and animal care records to
 ensure appropriate record keeping for all animal records including procedures, observations,
 and animal care.
- Monthly audit of all animal records including breeding and lab notebooks to ensure accurate
 and regular recording of animal care activities and procedures, and adequate PI oversight of
 recordkeeping.
- 4. The UW AV will attend and initially observe all surgical procedures to ensure that American Veterinary Medical Association-approved procedures are practiced. The AV will attend
