Dear Dr. Anderson,

The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your 30 July 2020 letter reporting a noncompliance with the PHS Policy on the Humane Care and Use of Laboratory Animals at the University of Washington. According to the information provided it is understood that in your Seattle facility, one NHP was left in a trapping run for at least 12 hours without access to food or water. Personnel noticed that this animal was not in the compound and looked in the trapping run but did not find her. She was found in the trapping run the next morning. She was mildly dehydrated, receive immediate treatment and recovered by the next day. It was not determined why the animal was in the trapping run.

Corrective Action: Water bottles have been added to those runs so animals always have access to water. Disciplinary action for involved staff will be undertaken in alignment with State and University personnel policies. No unallowable PHS funds were associated with this event.

OLAW believes that the corrective and preventive measures put in place by the University of Washington are consistent with the provisions of the PHS Policy on Humane Care and Use of Laboratory Animals for institutional self-monitoring and self-reporting. We appreciate being informed of this matter and find no cause for further action by this office.

Dear Dr. Morse:

This is a final report on a situation reported to OLAW by Dr. Stocking in a telephone call on 4/24/2020.

In a Seattle facility, 1 NHP was left in a trapping run for at least 12 hours without access to food or water. Personnel noticed that this animal was not in the compound, and looked in the trapping run but did not find her. She was found in the trapping run the next morning. She was mildly dehydrated, receive immediate treatment and recovered by the next day. There was a thorough investigation of the incident and we do not know why the animal was in the trapping run.

Corrective Action: Water bottles have been added to those runs so animals always have access to water. Disciplinary action for involved staff will be undertaken in alignment with State and University personnel policies.

The IACUC reviewed the incident at its May and July meetings and found no further action necessary. No unallowable PHS funds were associated with this event.
