
As you requested, we are terminating your Registration under the Animal Welfare Act (AWA) effective the date shown above.

All research facilities should complete items 4 through 13. Also required is the date, signature, and title of the Chief Executive Officer or other legally responsible official who attests to the accuracy of the report and to the assurance statements.
