The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your August 14, 2018 memo regarding an incident of noncompliance with the PHS Policy on Humane Care and Use of Laboratory Animals at the National Cancer Institute (NCI). According to the information provided, OLAW understands that on July 6, 2018 the NCI IACUC became aware that three individuals who had performed survival surgery procedures on mice used unacceptable surgical techniques, failed to adhere to the ACUC-approved protocol, and failed to use appropriate analgesics post-surgery. The PI was contacted and was asked to immediately stop all additional surgeries.

Corrective and preventive actions included having the individuals retake the OACU Animal User's Course and receive re-training from LASP veterinary staff on correct and appropriate surgical procedures and post-operative care. The individuals must also prove that they have read the ASP and perform the first surgery in the presence of an LASP veterinarian.

The actions taken to resolve the issue and prevent recurrence were appropriate and accepted by OLAW. We appreciate being informed of this matter and find no cause for further action by this office.

The event was first reported to the NCI ACUC Chair on July 6, 2018 as noted in the attached NCI ACUC memorandum. The details of the ACUC investigation and the corrective actions taken by the animal care program are outlined in the attached memorandum.

Reportable Animal Incident: Improper Surgery Techniques (009-18)

On July 6, 2018, I as Chair of the NCI ACUC, was apprised of an incident in an NCI animal facility involving three individuals who had performed survival surgery procedures (mice) using unacceptable surgical techniques, failed to adhere to the ACUC approved protocol, and failed to use appropriate analgesics post-surgery. There were no animal deaths as a result of the surgery. On July 6, 2018, the PI of the ASP was notified of the incident and the individuals were asked to immediately stop all additional surgeries. This incident was reported to OACU the same day. Upon further investigation into the incident, the NCI ACUC decided that the incident should be reported to OLAW. OACU was contacted and subsequently reported the incident to OLAW. The NCI ACUC developed a list of corrective measures that is shown below. The PI and the individuals who performed the surgery apologized for the incident and were willing to comply with the corrective measures.

In order to prevent further recurrence, the individuals conducting the surgery were instructed to perform the following corrective actions:

- · Immediately stopped from conducting surgical procedures on mice
- · Have the individuals retake the OACU Animal User's Course
- Have the individuals receive re-training from LASP veterinary staff on correct and appropriate surgical procedures and post-operative care
- · Individuals provide evidence to LASP veterinarians that the ASP had been read and followed
- After these measures, the individuals must demonstrate proficiency by performing the first surgery in the presence of an LASP veterinarian

This information was presented at the NCI ACUC meetings (July and August, 2018), where the ACUC approved the corrective measures. I feel with these measures in place this type of event is unlikely to reoccur in the future.
