The Institutional Animal Care and Use Committee (IACUC) met from **1:37-3:17 PM** in proom .

The meeting was called to order at 1:37 PM. A quorum was present and the committee was properly constituted.

Welcome & Introductions:

Review of Last Month's Minutes

MOTION: The motion was made and seconded to approve the IACUC minutes as written for the December IACUC meeting. The IACUC voted to approve the motion. (10-In favor, 0-Opposed, 1-Abstained)

Full Committee Review

IP01762 Antidepressant and weight gain

Overview: The protocol studies the relationship between anti-depressants and weight gain. The current modification requests to add a new euthanasia method that is conditionally acceptable by the AVMA guidelines.

Discussion: The lab will be collecting pancreatic tissue and requires the blood pH to be maintained during euthanasia. The use of anesthetics has shown to change blood pH which would affect the results. Verification regarding personnel proficiency and training may be needed to meet the conditions in the AVMA guidelines. Personnel should be trained by DCM staff and perform the new euthanasia method under supervision for verification of proficiency. The pain category should not change with this new method as long as personnel are trained properly.

IP00445 Liver and pancreatic cell therapy

Overview: Lab is requesting an exception to the transportation policy for movement of rodent cages.

Discussion: The justification for requesting the exception is not scientific in nature. The IACUC recommended that the Researchers get a cart with multiple shelves to avoid having to stack cages during transit.

The meeting was called to order at 1:32. A quorum was present and the committee was properly constituted. **Welcome and Introductions:**

Review of January Minutes:

MOTION: The motion was made and seconded to approve the IACUC minutes as written for the January IACUC meeting. The IACUC voted to approve the motion. (7-For, 0-Against, 6-Abstained)

DCM Update:

- USDA routine inspection
 - o DCM presented a summary of the USDA inspection report on January 21.
- Marmoset
 - o The IACUC discussed an adverse event involving a marmoset. Pathology reports indicated the presence of a cranial abscess.
 - o The IACUC discussed the potential source of the abscess and methods for improving surgical procedures.
 - o The laboratory voluntarily delayed future surgeries until SOPs are reviewed and revised.
- DCM is consulting with the laboratory to modify approved SOPs and align them closely with recommendations of the Association of Primate Veterinarians. DCM will observe the next surgical procedure once the SOPs have been reviewed and revised.

Full Committee Review

IP00907 Immune-based therapeutic approaches for acute myeloid leukemia

Overview: This three year renewal uses mice as a model to study therapies for acute myeloid leukemia. Overall, the protocol was well written with a strong discussion of the 3-Rs. The protocol was called to full committee review due to a request for delayed weaning of pups.

Discussion: Delayed weaning in the protocol was to be augmented by nutritional supplementation with kitten milk replacer powder. The investigator's prior institution routinely used this supplement, and described its use in published research reports. Veterinarians clarified that KMR is not a sterile product, and they would recommend using sterile, mouse-specific supplements. The laboratory needs to specify the removal of a first litter of pups prior to the birth of a second litter as per OHSU IACUC policy.

Specifically, the IACUC would like the PI to include the years of experience working with this model and clarify how pressure is controlled for consistency in the pinprick assay. Lastly, the Committee would like the PI to address whether similar cage designs are utilized for the different assays and any effects this may have upon the studies or the stress experienced by the animals.

Discussion: The Committee would like the PI to estimate how often animals will be transported from to imaging during the 8 day to 3 month period. The PI should also address if there are known stresses due to transport that may result in mortality.

Overview: This 3-year renewal aims to study the delivery of siRNA and drugs using nanoparticles to treat cancer tumors and	
organ fibrosis in the mouse model.

Discussion: The protocol includes exceptions to institutional IACUC policy, including single housing and wire bottom caging, both of which were well justified. Additionally, the protocol requests that the total mass of tumors may exceed 10% of the mouse's body weight. In instances where these exceptions may occur, the PI should establish a baseline body condition score and estimate the approximate number of mice in which multiple tumor burden may exceed 10% of the animals' body weight.

Once multiple tumors have been identified or if ulcerated or necrotic tumors have been identified, mice should be monitored daily. The protocol also includes serial blood collection. The PI should list personnel performing the procedures and clarify that only personnel with documented training and demonstrated proficiency will be performing serial retro-orbital blood collection procedures. Lastly, the protocol includes fasting. The PI should provide additional information about how the duration of fasting was determined and whether the duration could be decreased.

Full Committee Review

IP03077 SARS-CoV-2 Susceptible Mouse Alleles by i-GONAD (COVID-19 Research)

Overview: Initial protocol to develop a transgenic mouse model for SARS-CoV-2. The protocol was brought to full committee for discussion of biosafety issues. There is a large demand for this particular model.

Discussion: The lab has extensive experience creating transgenic mouse lines. Tail vein blood collection on pups was reviewed and deemed acceptable by the veterinarians. No animal welfare concerns.

The main biosafety concern is how to respond if animals test positive for SARS-CoV-2. Proper safety and containment practices would mitigate the risk of accidental infection of animals from animal care staff. If animals were to test positive to SARS-CoV-2, they could potentially infect other animals and animal care staff. Micro-isolating cages could mitigate the risk, but micro-isolating caging isn't currently available in the facility.

The IBC will evaluate risks and advise on best practices. After IBC approval, the IACUC will be updated on the status of the protocol.
